## INSPECTION OF THE 2023 FINAL REGISTER OF ELECTORS FOR FUNCTIONAL CONSTITUENCIES AND FINAL REGISTER OF VOTERS FOR SUBSECTORS

Owing to office relocation, the places for inspecting the functional constituencies final register and subsector final register have been updated. - (b) Registration and Electoral Office: 29th Floor, Standard Chartered Tower, Millennium City 1, 388 Kwun Tong Road, Kwun Tong, Kowloon.
