**PREVENTION AND CONTROL OF DISEASE (REGULATION OF CROSS-BOUNDARY CONVEYANCES AND TRAVELLERS) REGULATION**

In exercise of the powers under section 5 of the Prevention and Control of Disease (Regulation of Cross-boundary Conveyances and Travellers) Regulation (Chapter 599, sub. leg. H) (*Cap. 599H*), I hereby specify, with effect from 9 August 2022, for the purposes of the definition of *specified place* in section 2(1) and for the purposes of specifying different conditions for different types of relevant travellers under section 5(7):—

- (I) the following places outside Hong Kong as a specified place <sup>[Note]</sup>:—
- (1) all places outside China;
  - (2) the Mainland (except Guangdong Province);
  - (3) Macao; and
  - (4) Taiwan.

G.N. (E.) 564 of 2022 will be suspended upon the commencement of the above specification on 9 August 2022.

**Note:—**

The following matters relevant to all places outside China, the Mainland (except Guangdong Province), Macao and Taiwan (*the relevant specified places*) are specified in separate notices published in the Gazette:—

- (1) The quarantine period as mentioned in section 3(1) of the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Chapter 599, sub. leg. C) (*Cap. 599C*) and of the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Chapter 599, sub. leg. E) (*Cap. 599E*) for persons having stayed in the relevant specified places are respectively specified in G.N. (E.) 744 of 2022 and G.N. (E.) 745 of 2022 published in the Gazette by the Secretary for Health (*Secretary*) under section 11A of the respective regulations on 8 August 2022.
- (2) The period as mentioned in the definition of *relevant period* in section 3(9) of Cap. 599C and section 3(8) of Cap. 599E, in relation to the relevant specified places in which a person has stayed before arriving at Hong Kong, are respectively specified in G.N. (E.) 744 of 2022 and G.N. (E.) 745 of 2022 published in the Gazette by the Secretary under section 11A of the respective regulations on 8 August 2022.
- (3) The conditions as mentioned in section 5(1) of Cap. 599H for *relevant travellers* who have stayed in any place under the relevant specified places, and the *specified period* as mentioned in section 5(2B) of Cap. 599H in relation to the relevant specified places in which a relevant traveller has stayed before the relevant traveller boarded a specified conveyance, are specified in G.N. (E.) 563 of 2022 (until 11 August 2022) and G.N. (E.) 746 of 2022 (from 12 August 2022) published in the Gazette by the Secretary under section 5 of Cap. 599H on 30 May 2022 and 8 August 2022.
