

**PREVENTION AND CONTROL OF DISEASE (REQUIREMENTS AND DIRECTIONS)  
(BUSINESS AND PREMISES) REGULATION**

**Directions in Relation to Scheduled Premises**

I hereby exercise the power conferred on me by section 8 of the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Chapter 599, sub. leg. F) (*Regulation*) to direct that for a period of 14 days beginning on 25 November to 8 December 2021 (*Specified Period*):—

- (I) the following premises as set out in Part 1 of Schedule 2 to the Regulation may operate in one of the modes of operation as specified in paragraph (I)(A) or (I)(B) (except for the scheduled premises specified in item (I)(1) which may only operate in the mode of operation specified in paragraph (I)(A)) if they have adopted the specific measures required and the requirements and restrictions <sup>[Note 9]</sup> detailed at Annex, otherwise it must be closed:—

- (1) Bathhouse;
- (2) Premises (commonly known as *party room*) that are maintained or intended to be maintained for hire for holding social gatherings;
- (3) Establishment (commonly known as *club or nightclub*) that is open late into the night, usually for drinking, and dancing or other entertainment;
- (4) Karaoke establishment <sup>[Note 4]</sup>; and
- (5) Mahjong-tin kau premises;

(A) Type 1 Mode of Operation:—

(1) specific measures required:—

- (a) it must be ensured that all staff members involved in the operation of the premises have received the first dose of coronavirus disease 2019 (*COVID-19*) vaccine <sup>[Notes 1 and 2]</sup> and keep the vaccination record as proof of vaccination;
- (b) it must be ensured that all customers have received the first dose of vaccine <sup>[Notes 1 and 3]</sup> (this paragraph is not applicable to the scheduled premises specified in paragraph (I)(5)); and
- (c) before the customer is allowed to enter the premises, it must be ensured he/she scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone;

(2) mode of operation:—

- (a) in respect of the scheduled premises specified in items (I)(1) to (I)(4), they must be closed from 2.00 a.m. to 8.59 a.m.; only in respect of the scheduled premises specified in item (I)(5), it must be closed from midnight to 11.59 a.m. on the subsequent day;
- (b) the number of customers at any premises at any one time must not exceed 75% of the normal seating capacity or normal capacity of the premises (this paragraph is not applicable to the scheduled premises specified in item (I)(1));
- (c) only in respect of party room, no more than 8 persons may be allowed at each room or area in the party room where each room or area must be separated from the rest of the party room by effective partitioning;
- (d) only in respect of club or nightclub and mahjong-tin kau premises, no more than 4 persons may be allowed to be seated together at one table or to be allowed in the same group; and
- (e) only in respect of karaoke establishment, no more than 8 persons may be allowed to be seated together at one table or to be allowed in the same group;

- (B) Type 2 Mode of Operation (not applicable to the scheduled premises specified in item (I)(1)):  
(1) specific measures required:—
- (a) it must be ensured that all staff members involved in the operation of the premises have completed the vaccination course <sup>[Notes 1 and 2]</sup> and keep the vaccination record as proof of vaccination;
  - (b) it must be ensured that all customers have received the first dose of vaccine <sup>[Notes 1 and 3]</sup>; and
  - (c) before the customer is allowed to enter the premises, it must be ensured he/she scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone;
- (2) mode of operation:—
- (a) only in respect of the scheduled premises specified in items (I)(2) to (I)(4), they must be closed from 4.00 a.m. to 4.59 a.m.; only in respect of the scheduled premises specified in item (I)(5), it must be closed from midnight to 11.59 a.m. on the subsequent day;
  - (b) the number of customers at any premises at any one time must not exceed 100% of the normal seating capacity or normal capacity of the premises;
  - (c) only in respect of party room, no more than 12 persons may be allowed at each room or area in the party room where each room or area must be separated from the rest of the party room by effective partitioning;
  - (d) only in respect of club or nightclub, no more than 8 persons may be allowed to be seated together at one table or to be allowed in the same group;
  - (e) only in respect of karaoke establishment, no more than 12 persons may be allowed to be seated together at one table or to be allowed in the same group; and
  - (f) only in respect of mahjong-tin kau premises, no more than 4 persons may be allowed to be seated together at one table or to be allowed in the same group;
- (C) a scheduled premises (except that specified in item (I)(1)) that is operating in the mode of operation specified in paragraph (I)(A) or (I)(B) above must display a notice with the following specifications and content round-the-clock at the entrance of its premises during the Specified Period:—
- (1) the size of the notice must not be less than 297 x 420 mm (A3 size);
  - (2) the letters in the notice must be black in colour, the font type must be Times New Roman, and the font size must not be less than 32; and
  - (3) the content of the notice must be displayed in a way that is clearly legible and in a location unobstructed, with the following information included:—
    - i. licence number (if applicable), name and address of the business;
    - ii. stating the type of scheduled premises to which it belongs;
    - iii. stating the mode of operation adopted;
    - iv. the corresponding period that the premises must be closed; and
    - v. the maximum number of persons allowed to be seated together at one table or to be in the same room;
- (D) in respect of the requirements and restrictions in relation to the mode of operation and infection control, the requirements and restrictions applicable to staff members involved in the operation of the premises/performers are set out below:—  
must produce the relevant vaccination record on request by the premises operator and keep such record <sup>[Notes 1 and 2]</sup>;
- (E) in respect of the requirements and restrictions in relation to the mode of operation and infection control, the requirements and restrictions applicable to the customers of premises are set out below:—

- (1) before entering a premises, must scan the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone;
  - (2) before entering a premises, must produce the relevant vaccination record to the premises operator (this item is not applicable to the scheduled premises specified in item (I)(5) operating in Type 1 Mode of Operation); and
  - (3) before entering a premises, must conduct body temperature screening;
- (F) no members of the public may gather in the above premises when they are closed; and
- (G) the restriction in paragraph (I)(F) above is a restriction imposed in relation to a group gathering and is applicable to a person who participates in a group gathering in the premises that needs to be closed, a person who organizes a group gathering in the premises that needs to be closed and a person who controls or operates the premises that needs to be closed in which a group gathering takes place;
- (II) the following premises as set out in Part 1 of Schedule 2 to the Regulation may open subject to the requirements and restrictions <sup>[Note 9]</sup> detailed at Annex:—
- (1) Amusement game centre;
  - (2) Fitness centre;
  - (3) Place of amusement;
  - (4) Place of public entertainment;
  - (5) Beauty parlour;
  - (6) Club-house;
  - (7) Massage establishment;
  - (8) Sports premises;
  - (9) Swimming pool;
  - (10) Hotel and guesthouse; and
  - (11) Event premises.
- (A) in respect of the requirements and restrictions applicable to the premises set out in items (II)(1) to (II)(11) above, the requirements and restrictions applicable to staff members involved in the operation of the premises/performers/event organiser(s) and person(s) who provides services for the event are set out below (whichever is applicable):—
- (1) must produce the record of the test result of the polymerase chain reaction-based nucleic acid test for COVID-19 conducted every 14 days (and the sample for such test must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup>) or the relevant COVID-19 vaccination record on request by the premises operator/manager/employer or event organizer; and
  - (2) must produce the relevant COVID-19 vaccination record on request by the premises operator/manager/employer or event organizer and keep such record <sup>[Notes 1 and 2]</sup> (only when the vaccination requirements in relation to the scheduled premises specified in items (II)(2), (II)(4), (II)(6), (II)(9), (II)(10) and (II)(11) are applicable);
- (B) in respect of the requirements and restrictions applicable to the premises set out in items (II)(1) to (II)(11) above, the requirements and restrictions applicable to customers/users on the premises are set out below (whichever is applicable):—
- (1) before entering a premises, must scan the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit;
  - (2) before entering a premises, must conduct body temperature screening; and
  - (3) must produce the relevant vaccination record to the premises operator/manager or event organizer as required (only when the vaccination requirements in relation to the scheduled premises specified in items (II)(2), (II)(6), (II)(9), (II)(10) and (II)(11) are applicable);

(III) Cruise ship as set out in Part 1 of Schedule 2 to the Regulation may provide passenger services in the mode of operation as specified in paragraph (III)(A) if they have adopted the specific measures required set out below and the requirements and restrictions <sup>[Note 9]</sup> detailed at Annex, otherwise it must not provide passenger services:—

(A) Mode of Operation for Cruise Ship:—

(1) specific measures required:—

- (a) it must be ensured that all staff members involved in the operation of the cruise ship have completed the vaccination course <sup>[Notes 1 and 5]</sup> and keep the vaccination record as proof of vaccination;
- (b) arrangements must be made for all staff members involved in the operation of the cruise ship to undergo a polymerase chain reaction based nucleic acid test for COVID-19 once every 14 days starting from 18 November 2021 and the sample for such test must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup>, and ensure that the premises operator/manager/employer or staff obtain the test result before 2 December 2021 and the end of every subsequent 14 day period and keep record of the relevant test results for 31 days (see note 5 for the regular testing arrangement for staff who are unfit to receive COVID-19 vaccination because of health reasons);
- (c) it must be ensured that all customers aged 12 or above have completed the vaccination course <sup>[Notes 1, 3 and 6]</sup>;
- (d) it must be ensured that all customers have produced a negative result proof of a polymerase chain reaction-based nucleic acid test for COVID-19 and the sample for such test must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup> with the test sample taken within 48 hours <sup>[Note 7]</sup> prior to boarding the cruise ship; and
- (e) before the customer is allowed to board the cruise ship, it must be ensured he/she scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone <sup>[Note 8]</sup>;

(2) mode of operation:—

- (a) the number of customers at any one time must not exceed 50% of the normal capacity of the cruise ship (starting from 1 December 2021, the number of customers at any one time must not exceed 75% of the normal capacity of the cruise ship); and
  - (b) no more than 4 persons may be allowed at each guest room; no more than 8 persons may be allowed to stay in a suite (i.e. a guestroom with more than one bedroom) (except in the circumstance set out in paragraph (8)(a) of Part O of the Annex); and no more than 12 persons may be allowed in a group at the public/common area of the cruise ship;
- (B) in respect of the requirements and restrictions in relation to the mode of operation and infection control, the requirements and restrictions applicable to staff members involved in the operation of the cruise ship are set out below:—
- (1) must produce the relevant vaccination record on request by the premises operator/manager/employer and keep such record <sup>[Notes 1 and 5]</sup>; and
  - (2) must produce the record of the test result(s) of the polymerase chain reaction-based nucleic acid test for , the sample for which must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup>, conducted (i) every 14 days (for staff members who are fully vaccinated) or (ii) every 7 days (for staff members who are not fully vaccinated <sup>[Note 5]</sup>) on request by the premises operator/manager/employer;
- (C) in respect of the requirements and restrictions in relation to the mode of operation and infection control, the requirements and restrictions applicable to the customers of the cruise ship are set out below:—

- (1) before boarding the cruise ship, must produce the relevant vaccination record to the premises operator/manager (for customers aged 12 or above only);
- (2) before boarding the cruise ship, must produce to the premises operator/manager the record of the test result of the polymerase chain reaction-based nucleic acid test for with the test sample taken within 48 hours <sup>[Note 7]</sup> which must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup>;
- (3) prior to boarding the cruise ship and entering relevant premises therein, must scan the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone <sup>[Note 8]</sup>; and use the alternative contact tracing device as per the guidelines of the premises operator/manager if provided with such a device; and
- (4) before boarding the cruise ship, must conduct body temperature screening.

**Note 1:—**

Having 'received the first dose of vaccine' means having received the first dose of the Sinovac vaccine (*CoronaVac vaccine*) or the first dose of Fosun Pharma/BioNTech vaccine (*Comirnaty vaccine*), or having received, in places outside of Hong Kong, one dose of vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's Thematic Website ([https://www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](https://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).

For both the CoronaVac vaccine and Comirnaty vaccine, completion of the vaccination course in general means having received two doses of vaccine at least 14 days ago, except for persons previously infected with COVID-19, who are to receive one dose of vaccine at least 14 days ago. For persons aged 12 to 17, they may be deemed to have completed the vaccination course after receiving one dose of Comirnaty vaccine at least 14 days ago. For individuals who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, they will also be regarded to have completed the vaccination course of the relevant vaccine(s), subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 Thematic Website ([https://www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](https://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)). If an individual who received COVID-19 vaccine(s) in places outside of Hong Kong is to enter a premises that is subject to the requirement about COVID-19 vaccination of customers or work at a premises that is subject to the requirement about vaccination of staff, he/she must:—

- (a) make a declaration to the relevant premises operator using the specified form available on the COVID-19 Thematic Website/relevant webpage of the Food and Environmental Hygiene Department (*FEHD*) and produce the vaccination record issued by the relevant local authority to the premises operator/manager; or
- (b) make a declaration to the Government on the non-local COVID-19 vaccination record, and produce to the relevant premises operator the QR code of vaccination record for local use issued by the Government (for methods of declaration, please refer to "FAQ – Non-local COVID-19 Vaccination Record" as published on the Government's COVID-19 Vaccination Programme Thematic Website ([www.covidvaccine.gov.hk/en/faq](http://www.covidvaccine.gov.hk/en/faq))).

The 14th day before a person has completed a vaccination course is counted by taking the next day after the person received vaccine as the 1st day. For example, for a person who has not been infected with previously and who received the second dose of CoronaVac vaccine or Comirnaty vaccine on 29 April 2021, the '1st day' would be 30 April 2021 and the '14th day' would be 13 May 2021, on and after which the person would be considered to have completed a vaccination course.

In respect of premises to which the requirement that staff members must have completed a COVID-19 vaccination course is applicable, if there are staff members who had been issued a medical certificate proving that they were unfit for COVID-19 vaccination because of health reasons, and such staff members subsequently received COVID-19 vaccination, then:—

for (a) such staff members who have received the first dose of Comirnaty vaccine or CoronaVac vaccine; (b) such staff members who have received the second dose of Comirnaty vaccine or CoronaVac vaccine but it has been less than 14 days after such vaccination; (c) such staff

members who have received one dose of Comirnaty vaccine or CoronaVac vaccine but it has been less than 14 days after such vaccination and who were previously infected with COVID-19; or (d) such staff members aged 17 or below and employed in compliance with the Employment Ordinance (Chapter 57) who have received one dose of Comirnaty vaccine but it has been less than 14 days after such vaccination, they would be deemed to have complied with the requirement that staff members must have completed a COVID-19 vaccination course if they adopt the following measures, notwithstanding the fact that they have not completed a COVID-19 vaccination course:—

- (i) premises operator must ensure that such staff members keep the above medical certificate (regardless of whether the validity period of that certificate had expired before such staff members received the relevant vaccine);
- (ii) premises operator must arrange for such staff members to undergo a polymerase chain reaction based nucleic acid test for COVID-19 once every 7 days starting from 18 November 2021 and the sample(s) of the test(s) conducted must be taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup>, and ensure that such staff obtain SMS (mobile phone text message) notification containing the result of the test before 25 November 2021 and the end of every subsequent 7-day period and keep record of each SMS notification for 31 days;
- (iii) (only applicable to the staff members in item (a)) premises operators must ensure that such staff members have already made an appointment for receiving the second dose of Comirnaty vaccine or CoronaVac vaccine and the date of appointment for the second dose of vaccine and the date of receiving the first dose of vaccine can at most be 35 days apart, and ensure that the relevant staff members keep record of the above appointment; and
- (iv) premises operator must ensure that such staff members keep the relevant COVID-19 vaccination record.

**Note 2:—**

If a staff member involved in the operation of the business on the premises or a performer at the scheduled premises specified in item (I)(3) is unfit to receive vaccination because of health reasons, then he/she must make a declaration using the specified form available on the Thematic Website/relevant webpage of the FEHD and produce a medical certificate to the relevant premises operator/employer, as well as undergo a polymerase chain reaction-based nucleic acid test for using a test sample taken through combined nasal and throat swabs which must not be taken by the person being tested <sup>[Note 10]</sup> once every 7 days starting from 18 November 2021, and ensure that a SMS notification containing the result of the test is obtained before 25 November 2021 and the end of every subsequent 7-day period and keep record of each SMS notification for 31 days. The relevant premises operator/employer must keep the above declaration form(s). A premises operator and the relevant staff member or performer who satisfy the above conditions may be deemed to have complied with the relevant requirement about staff or performer receiving vaccination.

**Note 3:—**

Premises operator must download and install the “QR Code Verification Scanner” mobile application provided by the Government from App Store, Google Play or HUAWEI AppGallery according to the operating system of his or her mobile device and use the mobile application to scan the customers’ QR code of vaccination record for checking whether the customers (except for individuals who received vaccine(s) in places outside of Hong Kong <sup>[Note 11]</sup>) have complied with the relevant requirement about vaccination.

**Note 4:—**

For a business premises operating as karaoke establishments prior to the commencement of the Specified Period, it may choose, in accordance with paragraph (C)(I)(g) of G.N.(E.) 838 of 2021, to operate during the Specified Period solely as catering business without any karaoke activity being conducted on the premises in one of the modes of operation of catering business under paragraph (A) of that notice. Such business premises is not subject to the directions under this notice but is instead subject to the directions under G.N.(E.) 838 of 2021. Once a karaoke establishment has chosen to operate in the mode of operation of catering business, it may not change back to operate in the mode of operation under paragraph (I)(A) or (I)(B) of this notice during the Specified Period and vice versa.

**Note 5:—**

If a staff member involved in the operation of the business on the premises specified in paragraph (III) is unfit to receive vaccination because of health reasons, then he/she must make a declaration using the specified form available on the Thematic Website/relevant webpage of FEHD and produce a medical certificate to the relevant premises operator/manager/employer, as well as undergo a polymerase chain reaction-based nucleic acid test for using a test sample taken through combined nasal and throat swabs which must not be taken by the person being tested<sup>[Note 10]</sup> once every 7 days starting from 18 November 2021, and the premises operator/manager/employer or the relevant staff member must keep record of the relevant test results. The relevant premises operator/manager/employer must keep the above declaration form(s). A premises operator/manager/employer and the relevant staff member who satisfy the above conditions may be deemed to have complied with the relevant requirement about staff receiving vaccination.

**Note 6:—**

If a customer aged 12 or above as specified in paragraph (III) is unfit to receive vaccination because of health reasons, then he/she must make a declaration using the specified form available on the Thematic Website/relevant webpage of FEHD and produce a medical certificate to the relevant premises operator/manager. The relevant customer who satisfies the above conditions may be deemed to have complied with the relevant requirement about customer receiving vaccination.

**Note 7:—**

If within 72 hours prior to the customer's scheduled boarding time, a Tropical Cyclone Warning Signal No. 8 or above is in force or anticipated to be in force, then the customer may produce a negative result proof of a polymerase chain reaction-based nucleic acid test for with the test sample taken within 72 hours (instead of 48 hours) prior to boarding the cruise ship.

**Note 8:—**

If a person aged 15 or below or aged 65 or above is unable to use the 'LeaveHomeSafe' mobile application to record his or her visit to the relevant premises, the person or the premises operator/manager must register the person's name, contact number and the date and time of his/her visit with written or electronic records to be kept by the premises operator/manager for 31 days. A premises operator/manager and a customer aged 15 or below or aged 65 or above may be deemed to have complied with the relevant requirement about customer using the 'LeaveHomeSafe' mobile application if they have adopted the above measures.

**Note 9:—**

Among the requirements and restrictions, a person under the age of 2 is not required to comply with the requirement in relation to the wearing of mask within any scheduled premises.

**Note 10:—**

If a person who needs to comply with the requirement about undergoing polymerase chain reaction-based nucleic acid test(s) for COVID-19 (*the relevant test(s)*), and the sample(s) for such test(s) should be taken through combined nasal and throat swabs, is issued a medical certificate by a registered medical practitioner (*relevant medical certificate*), proving that he/she is unfit to undergo the relevant test(s) using sample(s) taken through combined nasal and throat swabs because of health reasons, then he/she may undergo the relevant test(s) using deep throat saliva sample(s). Relevant person must keep the SMS notification(s) containing the result(s) of the test(s) and the relevant medical certificate.

**REQUIREMENTS AND RESTRICTIONS ON SCHEDULED PREMISES AS SET OUT  
IN PART 1 OF SCHEDULE 2**

**(A) Amusement game centre**

- (1) a person must wear a mask at all times within any amusement game centre;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the amusement game centre;
- (3) hand sanitisers must be provided at any amusement game centre for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) it must be ensured that before a user is allowed to enter the premises, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (6) arrangements must be made for all staff members involved in the operation of the premises to undergo a polymerase chain reaction-based nucleic acid test for COVID-19 every 14 days starting from 18 November 2021 (and the sample for such test must be taken through combined nasal and throat swabs which must not be taken by the person being tested (see note 10 of the notice)) and ensure that the staff obtain SMS (mobile phone text message) notification containing the result of the test before 2 December 2021 and the end of every subsequent 14-day period and keep record of each SMS notification for 31 days (*the required testing arrangement*); or, adopt *alternative measure*, which is ensuring that the relevant staff member involved in the operation of the business on the premises has completed a vaccination course (see note 1 of the notice) and should keep the vaccination record as proof of vaccination;
- (7) game stations, machines or facilities next to one another and less than 1.5 metres apart must not be made available for use at the same time or there must be some form of partition which could serve as effective buffer between each game station, machine or facility;
- (8) no more than 4 persons may be allowed at each game station, machine or facility;
- (9) cleaning and disinfection of game stations, machines or facilities before use by the next customer or cleaning and disinfection of game stations, machines or facilities by applying disinfection materials with durable efficacy must be carried out;
- (10) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

Requirements or restrictions not adopted	Corresponding measures for reducing the risk of transmission
Any of those set out in paragraphs (1) to (3), (9)	Closure of the premises for 3 days
Any of those set out in paragraphs (7), (8)	Closure of the premises for 7 days
Any of those set out in paragraphs (4) to (6)	Closure of the premises for 14 days

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (11) for requirements and restrictions in relation to group gathering within any amusement game centre:—



- (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (7) and (8) above;
- (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (7) and (8) above; and
- (c) requirements or restrictions applicable to any person who controls or operates the amusement game centre in which a group gathering takes place are set out in paragraphs (7) and (8) above.

**(B) Bathhouse**

- (1) a person must wear a mask at all times within any bathhouse except when the person is having a shower, walking from a changing room to a pool or vice versa, walking from a pool to another pool, or having a bath;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the bathhouse;
- (3) hand sanitisers must be provided at the bathhouse for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) there must be a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between each person who is having a bath;
- (6) regular environmental cleaning and disinfection on the facilities must be carried out at least daily;
- (7) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (8) any part(s) of the premises being used or operated as a massage establishment must follow the requirements and restrictions as set out in Part G hereof;
- (9) steam and sauna facilities, if any, must be closed;
- (10) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

Any of those set out in paragraphs (1) to (3), (6), (7), (9)	Closure of the premises for 3 days
Any of those set out in paragraph (5), paragraph (I)(A)(2)(a) in the notice	Closure of the premises for 7 days

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (11) for requirements and restrictions in relation to group gathering within any bathhouse:—
  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraph (5) above;

- (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraph (5) above; and
- (c) requirements or restrictions applicable to any person who controls or operates the bathhouse in which a group gathering takes place are set out in paragraph (5) above.

**(C) Fitness centre**

- (1) subject to paragraphs (7), (14) and (15) below, a person must wear a mask at all times within any fitness centre except when the person is having a shower;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the fitness centre;
- (3) hand sanitisers must be provided at the fitness centre for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) subject to paragraph (15) below, it must be ensured that before a user is allowed to enter the premises, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (6) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure;
- (7) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
- (8) fitness stations, machines or equipment in use must be arranged in a way to ensure there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between each fitness station, machine or equipment;
- (9) no more than 4 persons may be allowed at each fitness station, machine or equipment;
- (10) there must be a distance of at least 1.5 metres between each training group or class, or some form of partition which could serve as effective buffer between each training group or class;
- (11) subject to paragraphs (12) and (13) below, each training group or class must consist of no more than 4 persons including the coach;
- (12) subject to paragraph (13) below, for a training group or class of more than 4 persons, there must be a distance of at least 1.5 metres between every participant (including the coach);
- (13) for a training group or class of more than 4 persons held in a room, each participant needs not be at least 1.5 metres apart from one another when one of the following sets of specified conditions is met:—
  - (I) training group or class comprising sub-groups of 4 persons
    - (a) all staff members present in the room must have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice);
    - (b) the training group or class must be conducted in a way to ensure that persons are arranged in sub-groups of no more than 4 persons and there is a distance of at least 1.5 metres between each sub-group or some form of partition which could serve as effective buffer between each sub-group;
    - (c) all persons who are present in the room must wear a mask at all times (including exercising); and
    - (d) in the course of training or conducting a class, the coach must stay at a fixed location at least 1.5 metres away from any other person in the room;

(II) training group or class comprising sub-groups of 12 persons

- (a) all staff members present in the room must have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice);
- (b) the training group or class must be conducted in a way to ensure that persons are arranged in sub-groups of no more than 12 persons and there is a distance of at least 1.5 metres between each sub-group or some form of partition which could serve as effective buffer between each sub-group;
- (c) all persons who are present in the room must wear a mask at all times (including exercising);
- (d) in the course of training or conducting a class, the coach must stay at a fixed location at least 1.5 metres away from any other person in the room; and
- (e) it must be ensured that in the relevant room, (i) the air change per hour (fresh air) (*ACH*) is 6 or above; or (ii) air purifiers of any of the following types that meet the specified specifications set out in FEHD's webpage have been installed:—
  1. High-Efficiency Particulate Arrestance Filter (HEPA) cum Ultraviolet-C (UV-C) device;
  2. High-Efficiency Particulate Arrestance Filter (HEPA) device; or
  3. Ultraviolet-C (UV-C) device;

and that a certificate (which must contain the relevant information as specified in the certificate template published on FEHD's webpage) filled in and signed by a registered specialist contractor (ventilation works category), specifying the ACH of the room, and the relevant information about the air purifiers installed (including type, brand, model, quantity and location) if the ACH of the room is not 6 or above, is displayed at a conspicuous location of the premises;

- (14) a person is not required to wear a mask when exercising in training groups/classes held in a room where the following specified conditions are met:—
  - (a) all persons (including staff members and other participants) present in the room must have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice);
  - (b) there must be a distance of at least 1.5 metres between each person, or some form of partition which could serve as effective buffer between each person (except for a training group or class not exceeding 4 persons); and
  - (c) any coach who is unable to receive COVID-19 vaccination because of health reasons must undergo regular testing (see note 2 of the notice) and wear a mask;
- (15) if any fitness centre meets the following specified conditions, then a person is not required to wear a mask when exercising in that fitness centre:—
  - (a) all staff members involved in the operation of the premises and all users must have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice);
  - (b) it must be ensured that before a user is allowed to enter the premises, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone;
  - (c) it must be ensured that in all exercise areas, (i) the ACH is 6 or above; or (ii) air purifiers of any of the following types that meet the specified specifications set out in FEHD's webpage have been installed:—
    1. High-Efficiency Particulate Arrestance Filter (HEPA) cum Ultraviolet-C (UV-C) device;
    2. High-Efficiency Particulate Arrestance Filter (HEPA) device; or
    3. Ultraviolet-C (UV-C) device;

and that certificate(s) (which must contain the relevant information as specified in the certificate template published on FEHD's webpage) filled in and signed by a registered specialist contractor (ventilation works category), specifying the ACH of the area(s), and the relevant information about the air purifiers installed

(including type, brand, model, quantity and location) if the ACH of the area(s) is not 6 or above, is displayed at a conspicuous location of the premises; and

- (d) any staff member who is unable to receive COVID-19 vaccination because of health reasons must undergo regular testing (see note 2 of the notice) and wear a mask when exercising;
- (16) fitness stations, machines or equipment must be cleaned and disinfected before and after each case;
- (17) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (18) steam and sauna facilities, if any, must be closed;
- (19) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (20) for requirements and restrictions in relation to group gathering within any fitness centre:—
  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (8) to (13) above;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (8) to (13) above; and
  - (c) requirements or restrictions applicable to any person who controls or operates the fitness centre in which a group gathering takes place are set out in paragraphs (8) to (13) above.

**(D) Place of amusement**

- (1) subject to paragraphs (9)(a) and (9)(g) below, a person must wear a mask at all times within any place of amusement except when the person is having a shower;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the place of amusement;
- (3) hand sanitisers must be provided at the place of amusement for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);

- (5) it must be ensured that before a user is allowed to enter the premises, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (6) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure;
- (7) for billiard establishment only:—
  - (a) billiard tables available for use must have a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between one table and another table, otherwise only alternate billiard tables may be opened for use;
  - (b) no more than 4 persons may be allowed to play at each billiard table; and
  - (c) cleaning and disinfection of facilities and accessories must be conducted before the use of the next hirer;
- (8) for public bowling-alley only:—
  - (a) some form of partition must be set between the sitting areas of adjacent lanes to serve as effective buffer between two groups of players at those lanes, otherwise only alternate lanes may be opened for use;
  - (b) no more than 4 persons may be allowed to play at each lane; and
  - (c) cleaning and disinfection of facilities and accessories must be conducted before the use of the next hirer;
- (9) for public skating rink only:—
  - (a) subject to paragraph (9)(f) below, a person (except a person, including a coach, working at the public skating rink) is not required to wear a mask when the person is doing exercise within the public skating rink during a training group or class of no more than 4 persons (including the coach);
  - (b) subject to paragraphs (9)(e), (9)(f), (9)(g) and (9)(h) below, only group/private lessons may be allowed;
  - (c) subject to paragraphs (9)(e) and (9)(h) below, there must be a distance of at least 1.5 metres between each group of users, or some form of partition which could serve as effective buffer between each group;
  - (d) subject to paragraphs (9)(e) and (9)(h) below, each group of users must consist no more than 4 persons (including the coach);
  - (e) for team sports, the maximum number of players and referees to be allowed in each public skating rink at any time during competition or training match must follow the rules and regulations of respective team sports competition;
  - (f) subject to the following conditions, individual users who are not participating in training groups or classes may be allowed, but the number of persons allowed within the premises must not exceed 50% of its normal capacity:—
    - (i) all staff members involved in the operation of the premises have completed the vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
    - (ii) all users are required to wear masks at all times (including when doing exercise);
  - (g) subject to the following conditions, individual users who are not participating in training groups or classes may be allowed and these users are not required to wear masks while the number of persons allowed within the premises must not exceed 100% of its normal capacity:—
    - (i) all staff members involved in the operation of the premises have completed the vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
    - (ii) all users have completed the vaccination course (see note 1 of the notice);

- (h) for spectator stands:—
  - (i) seats to be occupied must not exceed 85% of the seating capacity of the spectator stands; and
  - (ii) no more than 6 consecutive seats in the same row may be occupied; and
- (i) regular environmental cleaning and disinfection on the facilities must be carried out at least daily;
- (10) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (11) steam and sauna facilities, if any, must be closed;
- (12) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (13) for requirements and restrictions in relation to group gathering within any place of amusement:—
  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (7)(a), (7)(b), (8)(a), (8)(b), (9)(c) to (9)(e) and (9)(h)(ii) above;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (7)(a), (7)(b), (8)(a), (8)(b), (9)(b) to (9)(h) above; and
  - (c) requirements or restrictions applicable to any person who controls or operates the place of amusement in which a group gathering takes place are set out in paragraphs (7)(a), (7)(b), (8)(a), (8)(b), (9)(b) to (9)(h) above.

**(E) Place of public entertainment**

- (1) subject to paragraphs (14), (16)(a), (18)(a) and (18)(b) below, a person must wear a mask at all times within any place of public entertainment;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the place of public entertainment;
- (3) hand sanitisers must be provided at the place of public entertainment for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe'

mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);

- (5) it must be ensured that before a user is allowed to enter the premises, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (6) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure. For the avoidance of doubt, in respect of exhibitions, staff members involved in the operation of the premises include persons (excluding visitors and customers) who are present on the premises and involved in the operation of the exhibition booths or exhibition activities;
- (7) entertainment stations, machines or facilities, if any, next to one another and less than 1.5 metres apart must not be made available for use at the same time or there must be some form of partition which could serve as effective buffer between each entertainment station, machine or facility;
- (8) unless otherwise specified in this part, no more than 4 persons or the number of persons living in the same household, whichever is more, may be allowed in each group of visitors/guests/spectators/participants in a place of public entertainment, except for the following circumstance:—
  - (a) the persons are participating in a photo-taking session; and
  - (b) all of the relevant persons are wearing masks;
- (9) subject to paragraph (10) below, no more than 4 persons may be allowed at each entertainment station, machine or facility where applicable, or in the case of a large-scale entertainment station, machine, facility or venue, the number of persons to be allowed at any one time must not exceed 50% of the designed capacity (or 75% of the designed capacity for a large-scale entertainment station, machine or facility in a theme park) or 4 persons in each individual compartment or vehicle, whichever is more, of the entertainment station, machine, facility or venue;
- (10) the number of persons to be allowed would be 100% of the normal capacity of the premises subject to the following conditions:—
  - (a) all staff members involved in the operation of the premises have received the first dose of vaccine (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
  - (b) at least two-thirds of the visitors/guests/spectators/participants have received the first dose of vaccine (see note 1 of the notice);
- (11) cleaning and disinfection of entertainment stations, machines or facilities, if any, before use by the next customer or cleaning and disinfection of entertainment stations, machines or facilities by applying disinfection materials with durable efficacy must be carried out;
- (12) regular environmental cleaning and disinfection on the facilities including any storage cabinet must be carried out at least daily;
- (13) any ball pits must be closed;
- (14) catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
- (15) for cinema only:—
  - (a) subject to paragraph (10) above, tickets to be sold and seats to be occupied of each house for film screening must not exceed 85% of the seating capacity of the house;
  - (b) seating must be arranged in a way that no more than 6 consecutive seats in the same row may be occupied; except when the premises is operating under the circumstance set out in paragraph (10) above;
  - (c) no eating or drinking inside a house is allowed;

- (d) cleaning and disinfection of each house must be conducted after each screening; and
  - (e) no live performance is allowed;
- (16) for place of public entertainment with live performance only:—
- (a) a person is not required to wear a mask when the person is performing in a live performance or rehearsing within the place of public entertainment with (i) a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the person and any other person on the stage, and (ii) a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the performers and the audience or any visitor/guest (if any);
  - (b) a performer who does not wear a mask during rehearsal or performance must undergo a polymerase chain reaction-based nucleic acid test for COVID-19, the sample for which should be taken through combined nasal and throat swabs which must not be taken by the person being tested (see note 10 of the notice), within 7 days prior to the first entry to the place and every subsequent 14 days thereafter;
  - (c) subject to paragraph (10) above, tickets to be sold and seats to be occupied of each place with live performance must not exceed 85% of the seating capacity of the place;
  - (d) seating must be arranged in a way that no more than 6 consecutive seats in the same row may be occupied; except when the premises is operating under the circumstance set out in paragraph (10) above;
  - (e) no eating or drinking inside the place is allowed; and
  - (f) cleaning and disinfection of the place must be conducted after each performance/rehearsal;
- (17) for museum only:—
- (a) subject to paragraph (10) above, the total number of spectators in the museum must not at any one time exceed 85% of the capacity of the museum;
  - (b) no more than 4 persons may be allowed in each group of spectators;
  - (c) groups of spectators must be arranged in a way to ensure there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between each group; and
  - (d) no live performance is allowed;
- (18) for theme park only:—
- (a) subject to item (b) below, a person is not required to wear a mask when the person is performing in the outdoor area of the theme park or rehearsing in the theme park and there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the person and any other person (including visitor or the audience);
  - (b) a person is not required to wear a mask when the person is performing or rehearsing in the outdoor area of the theme park subject to the following condition: the performers have completed the vaccination course (see notes 1 and 2 of the notice);
  - (c) subject to paragraph (10) above, the total number of visitors in the theme park must not at any one time exceed 75% of the overall capacity of the theme park;
  - (d) live performance taking place in any indoor area of the theme park must follow the requirements and restrictions as set out in paragraph (16) above; and
  - (e) no live audience is allowed for rehearsals;
- (19) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

(20) for requirements and restrictions in relation to group gathering within any place of public entertainment:—

- (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (7), (8), (9), (15)(b), (16)(d), (17)(b) and (17)(c) above;
- (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (7), (8), (9), (10), (15)(a), (15)(b), (16)(c), (16)(d), (17)(a) to (17)(c) and (18)(c) above; and
- (c) requirements or restrictions applicable to any person who controls or operates the place of public entertainment in which a group gathering takes place are set out in paragraphs (7), (8), (9), (10), (15)(a), (15)(b), (16)(c), (16)(d), (17)(a) to (17)(c) and (18)(c) above.

**(F) Premises (commonly known as party room) that are maintained or intended to be maintained for hire for holding social gatherings**

- (1) subject to paragraph (5) below, a person must wear a mask at all times within any party room except when the person is consuming food or drink at a table therein;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the party room;
- (3) hand sanitisers must be provided at the party room for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation (a temporary catering premises which would only be used for hosting an one-off catering activity or banquet activity during the specified period needs not comply with the requirements relevant to registration with the Food and Environmental Hygiene Department (*FEHD*) in paragraphs (C)(I)(d) and (C)(II)(e)(2));
- (6) all equipment, games, furniture and facilities must be cleaned and disinfected before and after each booked session;
- (7) any part(s) of the party room being used or operated as karaoke establishment must follow the requirements and restrictions as set out in part J hereof;
- (8) any part(s) of the party room being used or operated as mahjong-tin kau premises must follow the requirements and restrictions as set out in part K hereof;
- (9) any ball pits must be closed;
- (10) any facility involving steam or vapour (except as part of eating, drinking or preparation of food or drink) must not be used; and

- (11) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

- (12) for requirements and restrictions in relation to group gathering within any party room:—
- (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (I)(A)(2)(c) and (I)(B)(2)(c) in the notice;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(c), (I)(B)(2)(b) and (I)(B)(2)(c) in the notice; and
  - (c) requirements or restrictions applicable to any person who controls or operates the party room in which a group gathering takes place are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(c), (I)(B)(2)(b) and (I)(B)(2)(c) in the notice above.

**(G) Beauty parlour and massage establishment**

- (1) a person must wear a mask at any time within any beauty parlour or massage establishment (*the establishment*) where applicable, except when the person is having facial treatment therein;
- (2) all staff must wear protective gears such as mask and face shield/goggles all the time when providing beauty or massage service to customers and the protective gears have to be changed or sanitised each time after service is provided to a customer;
- (3) body temperature screening on a person must be conducted before the person is allowed to enter the establishment;
- (4) hand sanitisers must be provided at the establishment for any person therein;
- (5) the poster containing the ‘LeaveHomeSafe’ venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the ‘LeaveHomeSafe’ mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (6) it must be ensured that before a user is allowed to enter the premises, the user scans the ‘LeaveHomeSafe’ venue QR code using the ‘LeaveHomeSafe’ mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (7) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure;
- (8) the establishment may only serve customers upon appointment;
- (9) service beds or seats must be arranged in a way to ensure there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between each bed or seat;
- (10) no more than 4 persons may be allowed in each partitioned service area during the provision of beauty or massage service;

- (11) all equipment, tools and service places or areas must be disinfected before and after each use;
- (12) all towels and consumables used must be changed after each use;
- (13) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (14) steam machines and vaporised chemicals must not be used at the establishment;
- (15) steam and sauna facilities, if any, must be closed;
- (16) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (9) and (10) above;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (9) and (10) above; and
  - (c) requirements or restrictions applicable to any person who controls or operates the establishment in which a group gathering takes place are set out in paragraphs (9) and (10) above.

#### **(H) Club-house**

- (1) subject to the applicable directions referred to in paragraphs (5), (8) to (19) below and except when taking a shower, a person must wear a mask at all times within any clubhouse;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the club-house;
- (3) hand sanitisers must be provided at the club-house for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
- (6) the following infection control recommendations must be applied to shower facilities:—

- (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (7) any part(s) of the club-house being used or operated as amusement game centre must follow the requirements and restrictions as set out in part A hereof;
  - (8) any part(s) of the club-house being used or operated as bathhouse, subject to the specific measures required and the requirements and restrictions as set out in part B hereof, may operate in the mode of operation as set out in paragraph (I)(A) of the notice. Otherwise any such part(s) must be closed;
  - (9) any part(s) of the club-house being used or operated as fitness centre must follow the requirements and restrictions as set out in part C hereof;
  - (10) any part(s) of the club-house being used or operated as place of amusement must follow the requirements and restrictions as set out in part D hereof;
  - (11) any part(s) of the club-house being used or operated as any forms of entertainment venue similar to place of public entertainment must follow the requirements and restrictions as set out in part E hereof;
  - (12) any part(s) of the club-house being used or operated as beauty parlour or massage establishment must follow the requirements and restrictions as set out in part G hereof;
  - (13) any part(s) of the club-house being used or operated as club or nightclub, subject to the specific measures required and the requirements and restrictions as set out in part I hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
  - (14) any part(s) of the club-house being used or operated as karaoke establishment, subject to the specific measures required and the requirements and restrictions as set out in part J hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
  - (15) any part(s) of the club-house being used or operated as mahjong-tin kau premises, subject to the specific measures required and the requirements and restrictions as set out in part K hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
  - (16) any part(s) of the club-house being used or operated as sport premises must follow the requirements and restrictions as set out in part L hereof;
  - (17) any part(s) of the club-house being used or operated as swimming pool must follow the requirements and restrictions as set out in part M hereof;
  - (18) any part(s) of the club-house being used or operated as hotel or guesthouse must follow the requirements and restrictions as set out in part N hereof;
  - (19) any part(s) of the club-house being used or operated as event premises must follow the requirements and restrictions as set out in part P hereof during the period when being used or operated as event premises;
  - (20) for meeting rooms or function rooms:—
    - (a) a person must wear a mask at all times within that room;
    - (b) subject to item (c) below, the number of persons must not at any one time exceed 50% of the normal capacity of that room;
    - (c) the number of persons may be 100% of the normal capacity of that room subject to the following conditions:
      - (i) all staff members involved in the operation of the room have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
      - (ii) at least two-thirds of the customers using the meeting room or function room have completed the vaccination course (see note 1 of the notice); and

- (d) no live performance or dancing activity is allowed (unless as part of specified events);
- (21) steam and sauna facilities, if any, must be closed;
- (22) any ball pits must be closed;
- (23) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

- (a) requirements and restrictions applicable to any person participating in a group gathering are set out in paragraph (20)(b) above;
- (b) requirements and restrictions applicable to any person who organizes any group gathering are set out in paragraphs (20)(b) and (20)(c) above; and
- (c) requirements and restrictions applicable to any person who controls or operates the club-house in which a group gathering takes place are set out in paragraphs (20)(b) and (20)(c) above.

**(I) Establishment (commonly known as club or nightclub) that is open late into the night, usually for drinking, and dancing or other entertainment**

- (1) subject to paragraphs (2) and (7) below, a person must wear a mask at all times within the establishment except when the person is consuming food or drink at a table therein;
- (2) a person working at the establishment must wear a mask at all time therein except when there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the person and any customer;
- (3) body temperature screening on a person must be conducted before the person is allowed to enter the club or nightclub;
- (4) hand sanitisers must be provided at the club or nightclub for any person therein;
- (5) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (6) tables available for use or being used by customers within any club or nightclub must be arranged in a way to ensure there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between one table and another table at the establishment;
- (7) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at paragraph (I)(A) or (I)(B) of this notice and paragraphs (C)(II), (D)(I), (D)(IV) and (E) of G.N. (E.) 838 of 2021 issued under the Regulation;
- (8) live performance is allowed in club or nightclub subject to the following conditions:
- (a) all performers have received the first dose of a COVID-19 vaccine (see notes 1 and 2 of the notice); and
- (b) adopt the necessary infection control measures as follows:—
- (i) performers should wear masks at all times;

- (ii) a distance of at least 1.5 metres should be kept between each performer as far as feasible;
  - (iii) a partition should be set up between the performers and audience/customers within the premises; and
  - (iv) no mingling between performers and audience/customers within the premises is allowed;
- (9) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraph (6) above and paragraphs (I)(A)(2)(b), (I)(A)(2)(d), (I)(B)(2)(b) and (I)(B)(2)(d) in the notice; and
  - (c) requirements or restrictions applicable to any person who controls or operates the club or nightclub in which a group gathering takes place are set out in paragraph (6) above and paragraphs (I)(A)(2)(b), (I)(A)(2)(d), (I)(B)(2)(b) and (I)(B)(2)(d) in the notice.

**(J) Karaoke establishment**

- (1) subject to paragraph (5) below, a person must wear a mask at all times within any karaoke establishment except when the person is consuming food or drink at a table therein;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the karaoke establishment;
- (3) hand sanitisers must be provided at the karaoke establishment for any person therein;
- (4) the poster containing the ‘LeaveHomeSafe’ venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the ‘LeaveHomeSafe’ mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at paragraph (I)(A) or (I)(B) of this notice and paragraphs (C)(II), (D)(I), (D)(IV) and (E) of G.N. (E.) 838 of 2021 issued under the Regulation;
- (6) all equipment, furniture and facilities must be cleaned and disinfected before and after each booked session;
- (7) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(e), (I)(B)(2)(b) and (I)(B)(2)(e) in the notice; and
  - (c) requirements or restrictions applicable to any person who controls or operates the karaoke establishment in which a group gathering takes place are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(e), (I)(B)(2)(b) and (I)(B)(2)(e) in the notice.

**(K) Mahjong-tin kau premises**

- (1) a person must wear a mask at all times within any mahjong-tin kau premises;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the mahjong-tin kau premises;
- (3) hand sanitisers must be provided at the mahjong-tin kau premises for any person therein;
- (4) the poster containing the ‘LeaveHomeSafe’ venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the ‘LeaveHomeSafe’ mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) tables next to one another and less than 1.5 metres apart must not be made available for use at the same time or there must be some form of partition which could serve as effective buffer between each table;
- (6) tile sets must be replaced with cleaned ones every time a new player joins or application of disinfection materials with durable efficacy on the tile sets must be carried out;
- (7) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraph (I)(A)(2)(d) in the notice;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(d), (I)(B)(2)(b) and (I)(B)(2)(f) in the notice; and
  - (c) requirements or restrictions applicable to any person who controls or operates the mahjong-tin kau premises in which a group gathering takes place are set out in paragraphs (I)(A)(2)(b), (I)(A)(2)(d), (I)(B)(2)(b) and (I)(B)(2)(f) in the notice.

**(L) Sports premises**

- (1) subject to paragraphs (2), (3) and (9) below, a person must wear a mask at all times within any sports premises except when the person is consuming a drink where reasonably necessary, having a shower, or doing exercise within any outdoor sports premises;
- (2) a person (except a person, including a coach, working at the sports premises) is not required to wear mask when the person is doing group exercise of no more than 4 persons (including the coach) within any indoor sports premises with a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between each group;
- (3) a person is not required to wear a mask when doing exercise within a certain part of an indoor sports premises where the following specified conditions are met:
  - (a) all staff members involved in the operation of the relevant part of the indoor sports premises must have completed the vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
  - (b) all users of the relevant part of the indoor sports premises must have completed the vaccination course (see note 1 of the notice);
- (4) body temperature screening on a person must be conducted as far as feasible before the person is allowed to enter the sports premises;
- (5) hand sanitisers must be provided at the sports premises for any person therein;
- (6) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (7) it must be ensured that before a user is allowed to enter the premises, as far as feasible, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (8) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure;
- (9) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
- (10) subject to paragraphs (12) and (13) below, there must be a distance of at least 1.5 metres between each group of users, or some form of partition which could serve as effective buffer between each group;
- (11) subject to paragraphs (12) and (13) below, each group of users must consist of no more than 4 persons, except for the following circumstance:
  - (a) the persons are participating in a photo-taking session; and



- (b) all of the relevant persons are wearing masks;
- (12) for team sports, the maximum number of players and referees to be allowed in each playing field/court at any time during competition or training match must follow the rules and regulations of respective team sports competition;
- (13) for spectator stands:—
  - (a) seats to be occupied must not exceed 85% of the seating capacity of the spectator stands; and
  - (b) no more than 6 consecutive seats in the same row may be occupied;
- (14) equipment must be cleaned and disinfected before and after each use;
- (15) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (16) steam and sauna facilities, if any, must be closed;
- (17) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

  - (a) requirements and restrictions applicable to any person participating in a group gathering are set out in paragraphs (10) to (12) and (13)(b) above;
  - (b) requirements and restrictions applicable to any person who organizes any group gathering are set out in paragraphs (10) to (13) above; and
  - (c) requirements and restrictions applicable to any person who controls or operates the sports premises in which a group gathering takes place are set out in paragraphs (10) to (13) above.

#### **(M) Swimming Pool**

- (1) subject to paragraph (2) below, a person (including a referee at a sports competition) must wear a mask at all times within any swimming pool except when the person is swimming, drinking where reasonably necessary, having a shower, walking from a changing room to a pool or vice versa, walking from a pool to another pool, or, where there is a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the person and any other person, is doing warm-up exercise;
- (2) a coach must wear a mask at all times when coaching;

- (3) body temperature screening on a person must be conducted before the person is allowed to enter the swimming pool;
- (4) hand sanitisers must be provided at the swimming pool for any person therein;
- (5) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than  $210 \times 297$ mm (A4 size);
- (6) it must be ensured that before a user is allowed to enter the premises, as far as feasible, the user scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the manager of the premises for 31 days;
- (7) arrangements must be made for all staff members involved in the operation of the premises to undergo testing according to the required testing arrangement; or, adopt alternative measure;
- (8) subject to paragraph (9) below, the number of persons to be allowed at any one time must not exceed 50% of the designed capacity of the swimming pool;
- (9) the number of persons to be allowed would be 100% of the designed capacity of the swimming pool subject to the following conditions:—
  - (a) all staff members involved in the operation of the pool have completed the vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
  - (b) all users have completed the vaccination course (see note 1 of the notice);
- (10) subject to paragraphs (12) and (13) below, there must be a distance of at least 1.5 metres between each training group or class, or some form of partition which could serve as effective buffer between each training group or class;
- (11) subject to paragraphs (12) and (13) below, each training group or class, except one taking place in a swimming lane/pool booked exclusively for training purpose, must consist of no more than 4 persons including the coach;
- (12) for team sports, the maximum number of players or swimmers and referees to be allowed in each playing field/pool at any time during competition or training match should follow the rules and regulations of respective sports competition;
- (13) for spectator stands:—
  - (a) seats to be occupied must not exceed 85% of the seating capacity of the spectator stands; and
  - (b) no more than 6 consecutive seats in the same row may be occupied;
- (14) regular environmental cleaning and disinfection on the facilities must be carried out at least daily;
- (15) the free residual chlorine content of the pool water must be maintained at a level of not less than 1 part per million (where chlorine compounds are used for disinfecting the pool water) or 0.5 part per million (where chlorine compounds are used to supplement disinfection by ozone of the pool water) at all times during which the pool is in use by bathers; a set of water testing kit must be provided, the pool water must be tested not less than once per day for its free residual chlorine content and the record of the test results must be kept;
- (16) the following infection control recommendations must be applied to shower facilities:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;

- (17) jacuzzi hot tub (if any) must remain closed;
- (18) steam and sauna facilities, if any, must be closed;
- (19) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

Requirements or restrictions not adopted	Corresponding measures for reducing the risk of transmission
Any of those set out in paragraphs (1) to (4), (14) to (18)	Closure of the premises for 3 days
Any of those set out in paragraphs (8), (10) to (13)	Closure of the premises for 7 days
Any of those set out in paragraphs (5) to (7), (9)	Closure of the premises for 14 days

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (20) for requirements and restrictions in relation to group gathering within any swimming pool:—
- requirements and restrictions applicable to any person participating in a group gathering are set out in paragraphs (10) to (12) and (13)(b) above;
  - requirements and restrictions applicable to any person who organizes any group gathering are set out in paragraphs (8) to (13) above; and
  - requirements and restrictions applicable to any person who controls or operates the swimming pool in which a group gathering takes place are set out in paragraphs (8) to (13) above.

#### (N) Hotel and guesthouse

- subject to the applicable directions referred to in paragraphs (6)(g), (9)(c)(ii), (10), (12)(a), (13) to (23) below and except when consuming food or drink, taking a shower, or within a guest room, a person must wear a mask at all times within any hotel/guesthouse;
- body temperature screening on a person must be conducted before the person is allowed to enter the hotel/guesthouse;
- hand sanitisers must be provided at the hotel/guesthouse for any person therein;
- the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- except those **Designated Quarantine Hotels/Guesthouses** published on the Government's thematic webpage on Designated Hotels for Quarantine ([www.designatedhotel.gov.hk](http://www.designatedhotel.gov.hk)), all other hotels/guesthouses must not accept persons under quarantine who have stayed in Taiwan or places outside China to undergo compulsory quarantine therein. **Persons under quarantine who have stayed in Taiwan or places outside China** means the relevant Taiwan travellers, the relevant Group A travellers, the relevant Group B travellers or the relevant Group C travellers as specified in the Gazette Notice issued pursuant to the Prevention and Control of Disease (Regulation of Cross-boundary Conveyances and Travellers) Regulation (Chapter 599, sub. leg. H), which is in force at the time and who are subject to compulsory quarantine upon arrival at Hong Kong;
- for Designated Quarantine Hotels/Guesthouses only:—
  - only persons under quarantine who have stayed in Taiwan or places outside China, carers who has undertaken to stay with those persons throughout the latter's stay at the hotel/guesthouse and persons who have stayed in Taiwan or places outside China and who are exempted from compulsory quarantine can be

- accepted as guests, and such guests may stay until one day after the end of the relevant quarantine period (if applicable);
- (b) members of the public must not have access to the hotel/guesthouse premises (except for lobby, customer service desks and carparks, etc., which have proper segregation and separate access control);
  - (c) subject to the applicable directions referred to in paragraph (6)(b) above, other non-accommodation facilities (including fitness centres, swimming pools, beauty parlours or massage establishments, business centres, catering premises, meeting rooms or function rooms, etc.) in the hotel/guesthouse must be closed;
  - (d) the manager must take all reasonable steps to ensure that guests under quarantine and any carers who has undertaken to stay with them could not leave their guest room/suite during their stay except in emergency situations or as directed by the Department of Health;
  - (e) the manager must take all reasonable steps to ensure that guests under quarantine could not receive any visitors into their guest room/suite during their stay (except for carers who have undertaken to stay with them throughout the latter's stay);
  - (f) the manager must comply with the infection control guidelines and directions issued by the Department of Health; and
  - (g) except when being within a guest room with the door(s) closed or as instructed by a person authorised to conduct testing at the hotel/guesthouse, a person under quarantine and carer who has undertaken to stay with that person throughout the latter's stay at the hotel/guesthouse (if any) must wear a mask (which must not be a mask with exhalation valve(s) or vent(s) which would allow exhaling air to escape) at all times within the hotel/guesthouse;
- (7) Non-designated quarantine guesthouses must not accept persons under quarantine as guests;
- (8) Non-designated quarantine hotels must not accept persons under quarantine who have stayed in Taiwan or places outside China as guests;
- (9) Except Designated Quarantine Hotels/Guesthouses, for guest rooms or rental units:—
- (a) a person visiting any guest room/rental unit therein must register his/her personal particulars with the manager;
  - (b) subject to paragraph (9)(c) below, at any one time, no more than 4 persons may be allowed to stay in a guest room/rental unit therein, and no more than 8 persons may be allowed to stay in a suite (i.e. a guestroom with more than one bedroom) therein;
  - (c) no more than 20 persons may be allowed to stay in a suite therein at one time during any religious or cultural ritual in relation to a wedding on the condition that:—
    - (i) the aforementioned ritual takes place between 8.00 a.m. to 5.00 p.m.; and
    - (ii) a person must wear a mask at all times within that suite except when consuming food or drink as part of the ritual;
  - (d) all areas, furniture and utensils etc. must be disinfected after each rental session;
  - (e) all towels and consumables used must be changed after each rental session; and
  - (f) if there is a person undergoing compulsory quarantine in the hotel/guesthouse (i.e. persons under quarantine who have stayed in China (except Taiwan) only):—
    - (i) the manager must arrange for persons under quarantine to stay in rooms which are segregated from those in which other persons not under quarantine are staying including by putting them on separate floors as far as practicable, and take all reasonable steps to ensure other guests would not have access to the floors where persons under quarantine are staying;
    - (ii) the manager must take all reasonable steps to ensure that the person and any carers who has undertaken to stay with him/her throughout the quarantine period could not leave his/her guest room/suite during the quarantine period except in emergency situations;

- (iii) the manager must take all reasonable steps to ensure that the person could not receive any visitors into the guest room/suite during the quarantine period (except for any carers who has undertaken to stay with the person under quarantine throughout the quarantine period); and
  - (iv) the manager must comply with the infection control guidelines and directions issued by the Department of Health;
- (10) subject to paragraph (6)(c) above, any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
- (11) subject to paragraph (6)(c) above, the following infection control recommendations must be applied to shower facilities in the communal area:—
  - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
  - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
  - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
  - (d) forbid sharing of personal items such as towel;
- (12) subject to paragraph (6)(c) above, for meeting rooms or function rooms:—
  - (a) a person must wear a mask at all times within that room;
  - (b) subject to item (12)(c) below, the number of persons must not at any one time exceed 50% of the normal capacity of that room;
  - (c) the number of persons may be 100% of the normal capacity of that room subject to the following conditions:—
    - (i) all staff members involved in the operation of the room have completed the COVID-19 vaccination course (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
    - (ii) at least two-thirds of the customers using the meeting room or function room have completed the vaccination course (see note 1 of the notice); and
  - (d) no live performance or dancing activity is allowed therein (unless as part of specified events);
- (13) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as bathhouse, subject to the specific measures required and the requirements and restrictions as set out in part B hereof, may operate in the mode of operation as set out in paragraph (I)(A) of the notice. Otherwise any such part(s) must be closed;
- (14) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as fitness centre must follow the requirements and restrictions as set out in part C hereof;
- (15) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as place of amusement must follow the requirements and restrictions as set out in part D hereof;
- (16) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as any forms of entertainment venue similar to place of public entertainment must follow the requirements and restrictions as set out in part E hereof;
- (17) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as beauty parlour or massage establishment must follow the requirements and restrictions as set out in part G hereof;
- (18) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as club or nightclub, subject to the specific measures required and the requirements and restrictions as set out in part I hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (19) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as karaoke establishment, subject to the specific measures required and the

requirements and restrictions as set out in part J hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;

- (20) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as mahjong-tin kau premises, subject to the specific measures required and the requirements and restrictions as set out in part K hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (21) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as sports premises must follow the requirements and restrictions as set out in part L hereof;
- (22) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as swimming pool must follow the requirements and restrictions as set out in part M hereof;
- (23) subject to paragraph (6)(c) above, any part(s) of the hotel/guesthouse being used or operated as event premises must follow the requirements and restrictions as set out in part P hereof during the period when being used or operated as event premises;
- (24) steam and sauna facilities, if any, must be closed;
- (25) any ball pits must be closed;
- (26) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

Those set out in paragraph (12)(c)	Closure of the relevant part(s) of the premises for 14 days

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (27) for requirements and restrictions in relation to group gathering within any hotel/guesthouse:—
  - (a) requirements and restrictions applicable to any person participating in a group gathering are set out in paragraphs (9)(b) and (9)(c) above;
  - (b) requirements and restrictions applicable to any person who organizes any group gathering are set out in paragraphs (9)(b), (9)(c), (12)(b) and (12)(c) above; and
  - (c) requirements and restrictions applicable to any person who controls or operates the hotel/guesthouse in which a group gathering takes place are set out in paragraphs (9)(b), (9)(c), (12)(b) and (12)(c) above.

#### **(O) Cruise Ship**

- (1) subject to the applicable directions referred to in paragraphs (6), (8) to (20) below, a person must wear a mask at all times within any cruise ship, except when consuming food or drink, taking a shower, or within a guest room;
- (2) body temperature screening on a person must be conducted before the person is allowed to enter the cruise ship;
- (3) hand sanitisers must be provided at the cruise ship for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance or at a conspicuous location of the cruise ship which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person boarding the cruise ship and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) in respect of facilities within the cruise ship, if the cruise operator/manager has provided with each customer with an alternative contact tracing device which would record the customer's visit to the part(s) of the premises where the use of the "LeaveHomeSafe" mobile application is required, and the device would record his/her visit each time to such part(s) concerned, the premises operator/manager is not

- required to ensure that, before he/she is allowed to enter the relevant part(s), each customer scans the 'LeaveHomeSafe' venue QR code or register his/her personal particulars and details of his/her visit. Otherwise, the premises operator/manager must ensure that, before he/she is allowed to enter the facilities concerned, each customer scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or register his/her name, contact number and the date and time of his/her visit with written or electronic records to be kept by the operator/manager of the premises for 31 days;
- (6) subject to paragraph (5) above, any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation;
  - (7) the following infection control recommendations must be applied to shower facilities in the communal area:—
    - (a) keep social distancing between users of at least 1.5 metres by opening alternate shower heads if they are not within individual cubicles;
    - (b) carry out cleaning and disinfection of the shower cubicles at least once every four hours;
    - (c) carry out regular environmental cleaning and disinfection on the facilities including storage cabinet at least daily; and
    - (d) forbid sharing of personal items such as towel;
  - (8) for guest rooms:—
    - (a) no more than 20 persons may be allowed to stay in a suite (i.e. a guestroom with more than one bedroom) therein at one time during any religious or cultural ritual in relation to a wedding on the condition that:—
      - (i) the aforementioned ritual takes place between 8.00 a.m. to 5.00 p.m.; and
      - (ii) a person must wear a mask at all times within that suite except when consuming food or drink as part of the ritual;
    - (b) all areas, furniture and utensils etc. must be disinfected after each voyage; and
    - (c) all towels and consumables used must be changed after each voyage;
  - (9) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as amusement game centre must follow the requirements and restrictions as set out in part A hereof;
  - (10) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as bathhouse, subject to the specific measures required and the requirements and restrictions as set out in part B hereof, may operate in the mode of operation as set out in paragraph (I)(A) of the notice. Otherwise any such part(s) must be closed;
  - (11) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as fitness centre must follow the requirements and restrictions as set out in part C hereof;
  - (12) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as place of amusement must follow the requirements and restrictions as set out in part D hereof;
  - (13) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as any forms of entertainment venue similar to place of public entertainment must follow the requirements and restrictions as set out in part E hereof;
  - (14) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as beauty parlour or massage establishment must follow the requirements and restrictions as set out in part G hereof;
  - (15) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as club or nightclub, subject to the specific measures required and the requirements and restrictions as set out in part I hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;

- (16) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as karaoke establishment, subject to the specific measures required and the requirements and restrictions as set out in part J hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (17) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as mahjong-tin kau premises, subject to the specific measures required and the requirements and restrictions as set out in part K hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (18) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as sports premises must follow the requirements and restrictions as set out in part L hereof;
- (19) subject to paragraph (5) above, any part(s) of the cruise ship being used or operated as swimming pool must follow the requirements and restrictions as set out in part M hereof;
- (20) if the whole cruise ship/any part(s) of the cruise ship fall within the definition of event premises, the Mode of Operation and specific measures for cruise ship under paragraph (III) of the notice and the other relevant requirements and restrictions as set out in this part must be followed, except that the meeting room(s) or function room(s) of the cruise ship when being used as event premises must, subject to paragraph (5) above, follow the requirements and restrictions for event premises as set out in part P hereof;
- (21) steam and sauna facilities, if any, must be closed;
- (22) any ball pits must be closed;
- (23) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the day and time as specified by an enforcement agent:—

if the corresponding measures for reducing the risk of transmission as set out above are not adopted on the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the day and time as specified by an enforcement agent; and

- (24) for requirements and restrictions in relation to group gathering within any cruise ship:—
  - (a) requirements and restrictions applicable to any person participating in a group gathering are set out in paragraph (8)(a) above and paragraph (III)(A)(2)(b) of the notice;
  - (b) requirements and restrictions applicable to any person who organizes any group gathering are set out in paragraph (8)(a) above and paragraph (III)(A)(2) of the notice; and
  - (c) requirements and restrictions applicable to any person who controls or operates the cruise ship in which a group gathering takes place are set out in paragraph (8)(a) above and paragraph (III)(A)(2) of the notice.

**(P) Event Premises**

- (1) subject to paragraphs (13) to (25) below, a person must wear a mask at all times within any event premises;



- (2) body temperature screening on a person must be conducted before the person is allowed to enter the event premises;
- (3) hand sanitisers must be provided at the event premises for any person therein;
- (4) the poster containing the 'LeaveHomeSafe' venue QR code must be displayed at the entrance of the premises or at a conspicuous location which must be unobstructed at any one time so that it is readily accessible for scanning by the 'LeaveHomeSafe' mobile application on mobile phone by a person entering the premises and the size of the image of the poster displayed must not be less than 210 × 297mm (A4 size);
- (5) it must be ensured that before a visitor/guest/spectator/participant is allowed to enter the premises, he/she scans the 'LeaveHomeSafe' venue QR code using the 'LeaveHomeSafe' mobile application on his/her mobile phone or registers his/her name, contact number and the date and time of his/her visit. The written or electronic records must be kept by the premises manager/event organiser for 31 days;
- (6) arrangements must be made for all event organizer(s) and person(s) who provides services for the event (if any) to undergo a polymerase chain reaction-based nucleic acid test for COVID-19 with test sample taken within 14 days prior to the day(s) the event is held (the sample for such test should be taken through combined nasal and throat swabs which must not be taken by the person being tested (see note 10 of the notice)) and ensure that the event organizer(s) and person(s) who provides services for the event obtain SMS notification containing the result of the test before the commencement of the event and keep record of each SMS notification for 31 days; or, adopt alternative measure, which is ensuring that the relevant persons has completed a vaccination course (see note 1 of the notice) and should keep the vaccination record as proof of vaccination. For the avoidance of doubt, in respect of exhibitions, event organizer(s) and person(s) who provides services for the event include persons (excluding visitors and customers) who are present on the premises and involved in the operation of the exhibition booths or exhibition activities;
- (7) unless otherwise specified in this part, no more than 4 persons or the number of persons living in the same household, whichever is more, may be allowed in each group of visitors/guests/spectators/participants in an event premises, except for the following circumstance:—
  - (a) the persons are participating in a photo-taking session; and
  - (b) all of the relevant persons are wearing masks;
- (8) subject to paragraph (9) below, the number of persons to be allowed at any one time must not exceed 50% of the normal capacity of the premises (if all visitors/guests/spectators/participants (excluding the organizer(s) and person(s) who provides services for the event) are to be accommodated in seating arranged in theatre setting or classroom setting in the course of the event, then the number of persons to be allowed in the event premises is not restricted by this paragraph and shall follow the requirement(s) set out in paragraph(s) (10) and/or (11) instead);
- (9) the number of persons to be allowed would be 100% of the normal capacity of the event premises subject to the following conditions:—
  - (a) all event organizer(s) and person(s) who provides services for the event (if any) have received the first dose of COVID-19 vaccine (see notes 1 and 2 of the notice) and keep the vaccination record as proof of vaccination; and
  - (b) at least two-thirds of the visitors/guests/spectators/participants (including the organizer(s)) have received the first dose of vaccine (see note 1 of the notice);
- (10) subject to paragraph (9) above, if there are spectator stands within the event premises:—
  - (a) seats to be occupied must not exceed 85% of the seating capacity of the spectator stands; and
  - (b) no more than 6 consecutive seats in the same row may be occupied;
- (11) subject to paragraph (9) above, for an event premises with seating arranged in theatre setting or classroom setting:—
  - (a) seats to be occupied must not exceed 85% of the seating capacity; and

- (b) seating must be arranged in a way that no more than 6 consecutive seats in the same row may be occupied;
- (12) subject to paragraphs (14) to (25) below, no eating or drinking (except as part of a religious ritual) is allowed at any one time within any event premises;
- (13) in respect of live performance:—
  - (a) a person is not required to wear a mask when the person is performing in a live performance or rehearsing within the event premises with:—
    - (i) a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the person and any other person on the stage, and
    - (ii) a distance of at least 1.5 metres or some form of partition which could serve as effective buffer between the performers and the audience or any visitor/guest (if any);
  - (b) a performer who does not wear a mask during rehearsal or performance must undergo a polymerase chain reaction-based nucleic acid test for COVID-19, the sample for which should be taken through combined nasal and throat swabs which must not be taken by the person being tested (see note 10 of the notice), within 7 days prior to the first entry to the premises and every subsequent 14 days thereafter (as applicable);
  - (c) no eating or drinking inside the place is allowed unless otherwise provided; and
  - (d) cleaning and disinfection of the place must be conducted after each performance/rehearsal;
- (14) any catering premises (premises on which food or drink is sold or supplied for consumption on the premises) therein must follow the applicable directions as set out at G.N. (E.) 838 of 2021 issued under the Regulation (a temporary catering premises which would only be used for hosting an one-off catering activity or banquet activity during the specified period needs not comply with the requirements relevant to registration with FEHD in paragraphs (C)(I)(d) and (C)(II)(e)(2));
- (15) any part(s) of the event premises being used or operated as amusement game centre must follow the requirements and restrictions as set out in part A hereof;
- (16) any part(s) of the event premises being used or operated as bathhouse, subject to the specific measures required and the requirements and restrictions as set out in part B hereof, may operate in the mode of operation as set out in paragraph (I)(A) of the notice. Otherwise any such part(s) must be closed;
- (17) any part(s) of the event premises being used or operated as fitness centre must follow the requirements and restrictions as set out in part C hereof;
- (18) any part(s) of the event premises being used or operated as place of amusement must follow the requirements and restrictions as set out in part D hereof;
- (19) any part(s) of the event premises being used for any form(s) of entertainment as defined under the Places of Public Entertainment Ordinance (Chapter 172) must follow the requirements and restrictions as set out in part E hereof;
- (20) any part(s) of the event premises being used or operated as beauty parlour or massage establishment must follow the requirements and restrictions as set out in part G hereof;
- (21) any part(s) of the event premises being used or operated as club or nightclub, subject to the specific measures required and the requirements and restrictions as set out in part I hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (22) any part(s) of the event premises being used or operated as karaoke establishment, subject to the specific measures required and the requirements and restrictions as set out in part J hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;
- (23) any part(s) of the event premises being used or operated as mahjong-tin kau premises, subject to the specific measures required and the requirements and restrictions as set out in part K hereof, may operate in the mode of operation as set out in paragraph (I)(A) or (I)(B) of the notice. Otherwise any such part(s) must be closed;

- (24) any part(s) of the event premises being used or operated as sport premises must follow the requirements and restrictions as set out in part L hereof;
- (25) any part(s) of the event premises being used or operated as swimming pool must follow the requirements and restrictions as set out in part M hereof;
- (26) if the requirements or restrictions below are not adopted, on being identified by an enforcement agent, the following corresponding measures for reducing the risk of transmission must be taken on the subsequent day:—

Requirements or restrictions not adopted	Corresponding measures for reducing the risk of transmission
Any of those set out in paragraphs (1) to (3), (12), (13)	Closure of the premises for 3 days
Any of those set out in paragraphs (7), (8), (10), (11)	Closure of the premises for 7 days
Any of those set out in paragraphs (4) to (6), (9)	Closure of the premises for 14 days

if the corresponding measures for reducing the risk of transmission as set out above are not adopted by the premises, on being identified by an enforcement agent, such corresponding measures must be taken on the subsequent day; and

- (27) for requirements and restrictions in relation to group gathering within any event premises:—
  - (a) requirements or restrictions applicable to any person participating in a group gathering are set out in paragraphs (7), (10)(b) and (11)(b) above;
  - (b) requirements or restrictions applicable to any person who organizes any group gathering are set out in paragraphs (7) to (11) above; and
  - (c) requirements or restrictions applicable to any person who controls or operates the event premises in which a group gathering takes place are set out in paragraphs (7) to (11) above.
