

**PREVENTION AND CONTROL OF DISEASE (COMPULSORY TESTING FOR CERTAIN PERSONS) REGULATION**

**Compulsory Testing Notice**

I hereby exercise the power conferred on me by section 10(1) of the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (*the Regulation*) (Chapter 599, sub. leg. J) to:—

**Category of Persons**

- (I) specify the following category of persons <sup>[Note 1]:</sup>—
- (a) any person who had been present on the following premises in any capacity (including but not limited to full-time, part-time and relief staff, students and visitors) for more than 2 hours at any time during the period from 16 November to 29 November 2021:—
    - (1) Baptist Oi Kwan Social Service Pui Yan Pre-Primary School, G/F, 1 Fortune Street, Cheung Sha Wan, Kowloon, Hong Kong;
    - (2) SAHK Shek Kip Mei Pre-School Centre, 116–130, G/F, Block 23, Shek Kip Mei Estate, Sham Shui Po, Kowloon, Hong Kong;
    - (3) The Neighbourhood Advice-Action Council Sun Chui Day Creche, Unit Nos. 5–16, G/F, Sun Kit House, Sun Chui Estate, Sha Tin, New Territories, Hong Kong;
    - (4) Heep Hong Society Chan Chung Hon Centre, Wings B & C, G/F, Sheung Yee House, Sheung Tak Estate, Tseung Kwan O, New Territories, Hong Kong;
    - (5) Yan Oi Tong Ng Wong Fung Ying Kindergarten Cum Nursery, 5/F, Tin Yiu Community Centre, Tin Yiu Estate, Tin Shui Wai, New Territories, Hong Kong;
    - (6) Garden Estate Baptist Nursery School, Room 37, 2/F, Lotus Tower 2, Garden Estate, 297 Ngau Tau Kok Road, Kwun Tong, Kowloon, Hong Kong;
    - (7) St Peter's Church Kindergarten, 23 Fortress Hill Road, North Point, Hong Kong;
    - (8) Hong Kong Society for the Protection of Children Esther Lee Day Crèche, G/F, Hong Ming House, Wah Ming Estate, Fanling, New Territories, Hong Kong;
    - (9) Tsung Tsin Mission Pak Tin Graceful Kindergarten, G/F, Shing Tin House, Pak Tin Estate, Shek Kip Mei, Kowloon, Hong Kong;
    - (10) Po Leung Kuk Yuen Long Early Learning Centre, Room 215–220, Ying Shui House, Shui Pin Wai Estate, Yuen Long, New Territories, Hong Kong;
    - (11) St. Peter's Church Kindergarten (Stanley)/St. Peter's Church Nursery (Stanley), Shop No 1, G/F, Kin Ma House, Ma Hang Estate, Stanley, Hong Kong;
    - (12) The Evangelical Lutheran Church of Hong Kong Cheung Wah Kindergarten (Main School), Units 101–108 & 113–115, G/F, Cheung Fung House, Cheung Wah Estate, Fanling, New Territories, Hong Kong;
    - (13) Precious Blood Kindergarten, 9 Holly Road, Happy Valley, Hong Kong;
  - (b) any person who had been present at Lai Chi Kok Park Sports Centre, 1 Lai Wan Road, Lai Chi Kok, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 2:00 p.m. to 4:00 p.m. on 11 November 2021;
  - (c) any person who had been present at Orange Zone of Level 5 or Orange Zone of Level 6 (Gate 25–71), Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 24 November to 27 November 2021;

**Requirements and Procedure for the Test**

- (II) require every person who falls within the above category to undergo a polymerase chain reaction-based nucleic acid test for the coronavirus disease 2019 (*the Specified Test*) in compliance with the requirements and procedure set out below <sup>[Note 2]:</sup>—

- (a) for a test at mobile specimen collection stations:—
- (i) attend one of the mobile specimen collection stations <sup>[Note 3]</sup> set up by the Government on or before 1 December 2021;
  - (ii) undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the stations; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (b) for a test at Community Testing Centres:—
- (i) attend one of the Community Testing Centres <sup>[Note 4]</sup> set up by the Government on or before 1 December 2021 during its opening hours;
  - (ii) undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the centre; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (c) for a test using a specimen bottle distributed to the places specified in Part (I) above by the Centre for Health Protection (**CHP**) (only applicable to persons who fall within the category specified in Part (I)(a) above):—
- (i) obtain a specimen bottle from the CHP;
  - (ii) collect relevant sample (which must not be deep throat saliva sample) in the aforesaid specimen bottle as per the guidelines in the specimen collection pack;
  - (iii) return, by 3 December 2021, the specimen bottle with the sample to one of the designated collection points <sup>[Note 5]</sup>; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (d) for a self-arranged test:—
- (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on [https://www.coronavirus.gov.hk/pdf/List\\_of\\_recognised\\_laboratories\\_RTPCR.pdf](https://www.coronavirus.gov.hk/pdf/List_of_recognised_laboratories_RTPCR.pdf) and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, by 1 December 2021, the Specified Test in accordance with the instructions given by the staff of the laboratory, including providing a sample taken through combined nasal and throat swabs; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

(III) require every person who falls within the above category to take appropriate personal disease prevention measures as far as reasonably practicable, including wearing a mask and maintaining hand hygiene; and unless for the purpose of undergoing the Specified Test, stay at his/her place of residence and avoid going out until the test result is ascertained as far as possible;

### **Period Specified for the Purpose of Section 14(3)(b) of the Regulation**

(IV) specify in relation to the category of persons in Part (I) above the 30-day period from 2 December to 31 December 2021 or the 30-day period from the day following the Extended Testing Period due to Inclement Weather <sup>[Note 6]</sup> as the period during which a Compulsory Testing Order may be issued under the Regulation upon non-compliance with this Notice; except for the category of persons in Part (I) above who had undergone the Specified Test in accordance with the requirements and procedure as specified in Part (II)(c) above, the corresponding 30-day period for whom is from 4 December 2021 to 2 January 2022 or the 30-day period from the day following the Extended Testing Period due to Inclement Weather <sup>[Note 6]</sup>;

### **Appointment of Prescribed Officers**

(V) appoint members of the Auxiliary Medical Service and all public officers of the Government of the Hong Kong Special Administrative Region to perform a function under the Regulation concerning a requirement specified under this Notice <sup>[Note 7]</sup>.

### **Note 1:—**

If a person who falls within the category specified in Part (I) above has previously undergone the Specified Test (in compliance with the requirements and procedure (except the relevant testing deadlines) set out in Part (II) above or Note 2 below) during the period from 27 November to 29 November 2021, he/she would be taken to have complied with the requirements set out in this Notice regardless of whether or not the test was conducted for complying with this Notice.

The category of persons specified in Part (I)(a) do not include a person who has completed a COVID-19 vaccination course. For both the Sinovac COVID-19 vaccine (*CoronaVac vaccine*) and Fosun Pharma/BioNTech COVID-19 vaccine (*Comirnaty vaccine*), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 17 November 2021, except for persons previously infected with COVID-19 who are to receive one dose of vaccine at least 14 days ago, i.e. having received the first dose of COVID-19 vaccine on or before 17 November 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 17 November 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for specified purposes as published on [https://www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](https://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

### **Note 2:—**

If a person who falls within the category specified in Part (I) above is issued a medical certificate by a registered medical practitioner (*relevant medical certificate*), proving that he/she is unfit to undergo the Specified Test using a sample taken through combined nasal and throat swabs in compliance with the requirements and procedure set out in Part (II) because of health reasons, then he/she may undergo the Specified Test using a deep throat saliva sample in compliance with the requirements and procedure set out below:—

- (a) for a test with a specimen bottle obtained:—
  - (i) obtain a specimen bottle from one of the 121 post offices, 47 general out-patient clinics of the Hospital Authority or vending machines set up at 20 MTR stations <sup>[Note 5]</sup>;
  - (ii) collect deep throat saliva sample in the specimen bottle as per the guidelines provided together with the specimen bottle;
  - (iii) return, by 1 December 2021, the specimen bottle with the sample to one of the designated collection points <sup>[Note 5]</sup>; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (b) for a test at general out-patient clinics of the Hospital Authority:—
- (i) undergo, by 1 December 2021, the Specified Test at general out-patient clinics of the Hospital Authority as instructed by a medical professional of the Hospital Authority; and
  - (ii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (c) for a self-arranged test using deep throat saliva sample:—
- (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on [https://www.coronavirus.gov.hk/pdf/List\\_of\\_recognised\\_laboratories\\_RTPCR.pdf](https://www.coronavirus.gov.hk/pdf/List_of_recognised_laboratories_RTPCR.pdf) and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, by 1 December 2021, the Specified Test in accordance with the instructions given by the staff of the laboratory; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test.

**Note 6:—**

If the tropical cyclone signal No. 3 or above is hoisted, or a red/black rainstorm warning signal or “extreme conditions after super typhoons” announced by the Government is/are in force at any time during the period for undergoing the Specified Test, the period for undergoing the Specified Test will be extended for 1 day (*the Extended Testing Period due to Inclement Weather*).

**Note 7:—**

Under the Regulation, health officers may, without the need of an appointment, perform a function concerning a requirement under a Compulsory Testing Notice.
