In exercise of the powers under section 5 of the Prevention and Control of Disease (Regulation of Cross-boundary Conveyances and Travellers) Regulation (Chapter 599, sub. leg. H) (*Cap.* 599H), I hereby specify, with effect from 1 January 2022, for the purposes of the definition of *specified place* in section 2(1) and for the purposes of specifying different conditions for different types of relevant travellers under section 5(7):—

- (1) The quarantine period as mentioned in section 3(1) of the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Chapter 599, sub. leg. C) (*Cap. 599C*) and of the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Chapter 599, sub. leg. E) (*Cap. 599E*) for persons having stayed in the relevant specified places are respectively specified in G.N. (E.) 746 of 2021 and G.N. (E.) 747 of 2021 published in the Gazette by the Secretary for Food and Health (*Secretary*) under section 11A of the respective regulations on 27 October 2021.
- (2) The period as mentioned in the definition of *relevant period* in section 3(9) of Cap. 599C and section 3(8) of Cap. 599E, in relation to the relevant specified places in which a person has stayed before arriving at Hong Kong, are respectively specified in G.N.
