**INSPECTION OF THE 2023 FINAL REGISTER OF ELECTORS FOR  
FUNCTIONAL CONSTITUENCIES AND  
FINAL REGISTER OF VOTERS FOR SUBSECTORS**

Pursuant to section 38 of the Electoral Affairs Commission (Registration) (Electors for Legislative Council Functional Constituencies) (Voters for Election Committee Subsectors) (Members of Election Committee) Regulation (Cap. 541B) (hereinafter referred to as “the Regulation”), it is hereby notified that a copy of the functional constituencies final register and a copy of the subsector final register are available for inspection by specified persons<sup>1</sup> from 25 September 2023 onwards during ordinary business hours (from 9:00 a.m. to 6:00 p.m.) from Monday to Friday (other than a general holiday) at the following places —

- (a) Registration and Electoral Office: 8<sup>th</sup> Floor, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon; and
- (b) Registration and Electoral Office: 13<sup>th</sup> Floor, Kowloonbay International Trade and Exhibition Centre, 1 Trademart Drive, Kowloon Bay, Kowloon.

<sup>1</sup> Pursuant to section 38(7) of the Regulation, *specified person* (指明的人), in relation to a functional constituencies final register or subsector final register, means —

- (a) a person who is a subscriber to the Government News and Media Information System maintained by the Director of Information Services;
- (b) a body or organization that is incorporated, or is registered or exempt from registration, under any law of Hong Kong and—
  - (i) was provided an extract under section 41(1) for a purpose related to a previous election;
  - (ii) was represented by a validly nominated candidate at a previous election; or
  - (iii) has publicly declared an intention to arrange for any person (including a person yet to be specified) to stand as a candidate at a coming election;
- (c) a person who is—
  - (i) for a functional constituencies final register—a validly nominated candidate for a functional constituency at a coming election; or
  - (ii) for a subsector final register—a validly nominated candidate for a subsector at a coming election; or
- (d) any member of the public who does not fall within paragraphs (a), (b) and (c).
