

# A BILL

## To

Apply a sum not exceeding \$697,844,512,000 to the services of the Government in the financial year ending on 31 March 2023.

Enacted by the Legislative Council.

**1. Short title**

This Ordinance may be cited as the Appropriation Ordinance 2022.

**2. Authorization of appropriation**

The appropriation in the manner expressed in the Schedule of a sum not exceeding \$697,844,512,000 from the general revenue for the services of the Government in the financial year commencing on 1 April 2022, and ending on 31 March 2023, is authorized.
