

**PREVENTION AND CONTROL OF DISEASE (COMPULSORY TESTING FOR CERTAIN PERSONS) REGULATION**

**Compulsory Testing Notice**

I hereby exercise the power conferred on me by section 10(1) of the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (*the Regulation*) (Chapter 599, sub. leg. J) to:—

**Category of Persons**

(I) specify the following category of persons:—

any person who had been present on any of the following premises in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from 23 February 2022 to 8 March 2022:—

- (1) Tin Wing House, Shun Tin Estate, Kwun Tong, Kowloon, Hong Kong (excluding unit 110 on G/F and Shun Tin Shopping Centre);
- (2) Tin Yiu House, Shun Tin Estate, Kwun Tong, Kowloon, Hong Kong (excluding Shun Tin Shopping Centre);
- (3) 80–82 Broadway, Mei Foo Sun Chuen Phase 3, Lai Chi Kok, Kowloon, Hong Kong (excluding the car park thereat and Delia Memorial School (Broadway));
- (4) 84–86 Broadway, Mei Foo Sun Chuen Phase 3, Lai Chi Kok, Kowloon, Hong Kong (excluding the car park thereat and Delia English Primary School & Kindergarten);
- (5) Block 4, Tsui Ning Garden, Tuen Mun, New Territories, Hong Kong (excluding the car park thereat and shops on G/F);
- (6) Block 5, Tsui Ning Garden, Tuen Mun, New Territories, Hong Kong (excluding the car park thereat and shops on G/F);
- (7) Block 6, Tsui Ning Garden, Tuen Mun, New Territories, Hong Kong (excluding the car park thereat and shops on G/F);
- (8) Block 1, Sherwood Court, Kingswood Villas, Yuen Long, New Territories, Hong Kong (excluding the car park thereat);
- (9) Block 2, Sherwood Court, Kingswood Villas, Yuen Long, New Territories, Hong Kong (excluding the car park thereat);
- (10) Block 5, Sherwood Court, Kingswood Villas, Yuen Long, New Territories, Hong Kong (excluding the car park thereat);

**AND** when the restriction-testing declaration (*declaration*) involving that premises made on 8 March 2022 became effective,

- (a) was present in the restricted area identified by the declaration (*Category A person*); **OR**
- (b) was not present in the restricted area identified by the declaration (*Category B person*);

**Requirements and Procedure for the Test**

(II) require every person falling within the specified categories to undergo a polymerase chain reaction-based nucleic acid test for the coronavirus disease 2019 (*the Specified Test*) in compliance with the requirements and procedure set out below <sup>[Note 1]</sup>:—

- (a) for a test at mobile specimen collection stations/temporary specimen collection stations:—
  - (i) in respect of a Category A person, within the period specified by prescribed officer(s) on 8 March or 9 March 2022 and, in respect of a Category B person, between 8 March and 10 March 2022, attend one of the mobile specimen collection stations/temporary specimen collection stations <sup>[Note 2]</sup> set up by the Government;
  - (ii) undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the station; and

- (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (b) for a test at Community Testing Centres:—
  - (i) attend one of the Community Testing Centres <sup>[Note 3]</sup> set up by the Government in accordance with the time or period specified under Part (II)(a)(i) in respect of Category A person and Category B person;
  - (ii) undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the centre; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (c) for a test using a specimen bottle distributed to the buildings specified in Part (I) above by the Centre for Health Protection (*CHP*)/public officer(s) (if applicable):—
  - (i) obtain a specimen bottle from the *CHP*/public officer(s);
  - (ii) collect relevant sample in the aforesaid specimen bottle as per the guidelines in the specimen collection pack;
  - (iii) return the specimen bottle with the sample to one of the designated collection points <sup>[Note 4]</sup>, in accordance with the time or period specified under Part (II)(a)(i) in respect of Category A person and Category B person; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (d) for a self-arranged test:—
  - (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on [https://www.coronavirus.gov.hk/pdf/List\\_of\\_recognised\\_laboratories\\_RTPCR.pdf](https://www.coronavirus.gov.hk/pdf/List_of_recognised_laboratories_RTPCR.pdf) and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, in accordance with the time or period specified under Part (II)(a)(i) in respect of Category A person and Category B person, the Specified Test in accordance with the instructions given by the staff of the laboratory, including providing a sample taken through combined nasal and throat swabs; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

(III) require every person who falls within the above category to take appropriate personal disease prevention measures as far as reasonably practicable, including wearing a mask and maintaining hand hygiene; and unless for the purpose of undergoing the Specified Test, stay at his/her place of residence and avoid going out until the test result is ascertained as far as possible;

**Period Specified for the Purpose of Section 14(3)(b) of the Regulation**

(IV) specify in relation to Category A person the 30-day period from 9 March to 7 April 2022 and in relation to Category B person the 30-day period from 11 March to 9 April 2022 as

the period during which a Compulsory Testing Order may be issued under the Regulation upon non-compliance with this Notice;

#### **Appointment of Prescribed Officers**

(V) appoint members of the Auxiliary Medical Service and all public officers of the Government of the Hong Kong Special Administrative Region to perform a function under the Regulation concerning a requirement specified under this Notice <sup>[Note 5]</sup>.

#### **Note 1:—**

If a person who falls within the category specified in Part (I) above is issued a medical certificate by a registered medical practitioner (*relevant medical certificate*), proving that he/she is unfit to undergo the Specified Test using a sample taken through combined nasal and throat swabs in compliance with the requirements and procedure set out in Part (II) because of health reasons, then he/she may undergo the Specified Test using a deep throat saliva sample in compliance with the requirements and procedure set out below:—

- (a) for a test with a specimen bottle obtained:—
  - (i) obtain a specimen bottle from one of the 120 post offices, 46 general out-patient clinics of the Hospital Authority or vending machines set up at 20 MTR stations <sup>[Note 4]</sup>;
  - (ii) collect deep throat saliva sample in the aforesaid specimen bottle as per the guidelines in the specimen collection pack;
  - (iii) return, in accordance with the time or period specified under Part (II)(a)(i) in respect of Category B person, the specimen bottle with the sample to one of the designated collection points <sup>[Note 4]</sup>; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

#### **OR**

- (b) for a test at general out-patient clinics of the Hospital Authority:—
  - (i) undergo, in accordance with the time or period specified under Part (II)(a)(i) in respect of Category B person, the Specified Test at general out-patient clinics of the Hospital Authority as instructed by a medical professional of the Hospital Authority; and
  - (ii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

#### **OR**

- (c) for a self-arranged test using deep throat saliva sample:—
  - (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on [https://www.coronavirus.gov.hk/pdf/List\\_of\\_recognised\\_laboratories\\_RTPCR.pdf](https://www.coronavirus.gov.hk/pdf/List_of_recognised_laboratories_RTPCR.pdf) and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, in accordance with the time or period specified under Part (II)(a)(i) in respect of Category B person, the Specified Test in accordance with the instructions given by the staff of the laboratory; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test.
