

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2335EM17T—Five-year Term Contract for Maintenance, Modification and Installation Works for Area Traffic Control System of Tuen Mun and Yuen Long District.**

The scope of the works includes maintenance, modification and installation works for the Area Traffic Control (ATC) System of Tuen Mun and Yuen Long District as well as provision of first line maintenance for traffic signals and accessories equipment. The Contract is scheduled to commence in May 2018 for completion in May 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to 'The Chairman, Public Works Tender Board' and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon, Friday, 23 March 2018. The tenderer shall have completed contract(s) for supply, installation, modification or maintenance of traffic signal controller in Hong Kong with an aggregate contract value of not less than HK\$18 million within the past 5-year period immediately preceding the tender closing date specified in the Government Gazette to tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this experience requirement.
