

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1200EM17T—Quadrennial Term Contract for Maintenance, Modification and Installation Works for Kowloon, Tsuen Wan, Shatin and Tseung Kwan O Area Traffic Control System.**

The scope of the works includes maintenance, modification and installation works for the Area Traffic Control (ATC) System of Kowloon, Tsuen Wan, Shatin and Tseung Kwan O as well as provision of first line maintenance for traffic signals and accessories equipment. The Contract is scheduled to commence in May 2018 for completion in May 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to 'The Chairman, Public Works Tender Board' and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon, Friday, 23 March 2018. Late tenders will not be accepted.

The tenderer shall have completed contract(s) for supply, installation, modification or maintenance of traffic signal controller in Hong Kong with an aggregate contract value of not less than HK\$15 million within the past 5-year period immediately preceding the tender closing date specified in the Government Gazette to tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this experience requirement.
