Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. SW/GZ004 (the 'Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) construction of about 400 metres of rising mains, gravity sewers and associated manholes within the limit of works area as shown on the Plan; and
- (ii) ancillary works including temporary closure and reinstatement of carriageways, footpaths and open space.

Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
