

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

EXTENSION OF EXISTING FOOTBRIDGE NO. KF90 ACROSS LEI YUE MUN ROAD
NEAR TSUI PING ROAD AND PROPOSED ROAD WORKS AT SHING YIP STREET,
KWUN TONG, KOWLOON

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. KM10023 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of an elevated covered walkway with associated column connecting the southern end of the existing footbridge No. KF90 to the future property development at New Kowloon Inland Lot No. 6195;
- (ii) construction of a temporary access ramp along King Yip Lane connecting the southern end of the existing footbridge No. KF90. The temporary access ramp will be demolished after completion of the elevated covered walkway mentioned in paragraph 2(i) above and the future property development at New Kowloon Inland Lot No. 6195;
- (iii) permanent closure and demolition of the existing access ramp connecting the southern end of the existing footbridge No. KF90 over the nullah near King Yip Lane;
- (iv) permanent closure and conversion of a section of the existing footpath into a pedestrian crossing at Shing Yip Street;
- (v) permanent closure and conversion of sections of the existing footpath into carriageway at Shing Yip Street;
- (vi) permanent closure and conversion of sections of the existing carriageway into traffic islands at Shing Yip Street;
- (vii) permanent closure and conversion of a section of the existing traffic island into carriageway at Shing Yip Street;
- (viii) permanent closure and conversion of a section of footpath under PWP Item No. 7771CL Development of Ex-Cha Kwo Ling Kaolin Mine Site as described in G.N. 3657 of 2015 and authorized as per G.N. 6604 of 2015 ('PWP Item No. 7771CL') into carriageway at Shing Yip Street;
- (ix) permanent closure and conversion of a section of carriageway under PWP Item No. 7771CL into traffic island at Shing Yip Street;
- (x) permanent closure and conversion of sections of traffic islands under PWP Item No. 7771CL into carriageway at Shing Yip Street;
- (xi) demolition and conversion of the existing roadside planter into carriageway at Shing Yip Street;
- (xii) demolition and conversion of a section of the existing roadside planter into footpath at Shing Yip Street;
- (xiii) temporary closure and conversion of sections of the existing footpath into the temporary access ramp mentioned in paragraph 2(ii) above;
- (xiv) temporary closure and reconstruction of a section of the existing traffic island at Shing Yip Street;
- (xv) temporary closure and reconstruction of sections of traffic islands under PWP Item No. 7771CL at Shing Yip Street; and
- (xvi) ancillary works including drainage, water, sewerage, utility, public lighting and landscaping works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 27th day of April 2021.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
