## ELECTORAL AFFAIRS COMMISSION (REGISTRATION) (ELECTORS FOR LEGISLATIVE COUNCIL FUNCTIONAL CONSTITUENCIES) (VOTERS FOR ELECTION COMMITTEE SUBSECTORS) (MEMBERS OF ELECTION COMMITTEE) REGULATION (Chapter 541B)

(Sections 25 and 29 of the Regulation)

## INSPECTION OF THE 2021 PROVISIONAL REGISTER OF VOTERS AND THE OMISSIONS LIST

Pursuant to sections 25 and 29 of the Electoral Affairs Commission (Registration) (Electors for Legislative Council Functional Constituencies) (Voters for Election Committee Subsectors) (Members of Election Committee) Regulation (Cap. 541B) (hereinafter referred to as "the Regulation"), the judgment handed down by the Court of Appeal on 21 May 2020 and the order made at the hearing on 27 May 2020 [Case no. CACV 73/2020], if applicable<sup>1</sup>, it is hereby notified that—

- (a) a copy of the subsector provisional register; and
- (b) a copy of the subsector omissions list containing the personal particulars or relevant particulars of persons who are no longer eligible to have their names included or who do not wish to remain registered in the subsector register,

are now available for inspection during ordinary business hours (from 9:00 a.m. to 6:00 p.m.) of the five days from 18 July to 22 July 2021, both days inclusive<sup>2</sup>. The places for inspection are as follows—

- (a) Registration and Electoral Office: 10<sup>th</sup> Floor, Harbour Centre, 25 Harbour Road, Wan Chai, Hong Kong; and
- (b) Registration and Electoral Office: 13<sup>th</sup> Floor, Kowloonbay International Trade and Exhibition Centre, 1 Trademart Drive, Kowloon Bay, Kowloon.

The parts of the provisional register and the omissions list containing the names and principal residential addresses of individual voters will only be provided for inspection by members of press and political parties, while the relevant parts

containing the registered particulars of corporate voters will be provided for inspection by members of the public.

Any person who considers that a registered person is not eligible to be registered as a voter or an authorized representative, or be registered in the part in which that person's personal particulars or relevant particulars are recorded; or that a person who has been registered as an authorized representative has been wrongly so registered, may, under section 30 of the Regulation, lodge and deliver in person<sup>3</sup> at the office of the Electoral Registration Officer not later than 22 July 2021 a notice of objection in the specified form. The address of the office of the Electoral Registration Officer is set out in the form.

Any person who has made an application for registration as a voter but whose personal particulars or relevant particulars are not recorded in the provisional register; or whose appointment of authorized representative was refused by the Electoral Registration Officer; or whose personal particulars or relevant particulars are included in the omissions list; or who has a claim regarding his or her or its particulars in the provisional register may, under section 31 of the Regulation, make a claim and deliver in person<sup>4</sup> at the office of the Electoral Registration Officer not later than 22 July 2021 a notice of claim in the specified form. The address of the office of the Electoral Registration Officer is set out in the form.

Special arrangement will be made by the office of the Electoral Registration Officer to operate on 18 July 2021 (Sunday), meaning the office of the Electoral Registration Officer will receive the relevant notices from 9:00 a.m. to 6:00 p.m. during the period from 18 July to 22 July 2021, both dates inclusive.

Any corporate voter who is dissatisfied with the decision of the Electoral Registration Officer not to register as an authorized representative a person appointed by that corporate as a replacement or as a substitute may, under section 31A of the Regulation, deliver in person by its responsible person at the office of the Electoral Registration Officer a notice of appeal in the specified form. The address of the office of the Electoral Registration Officer is set out in the form.
