## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

### (Notice under section 8(2))

# PROPOSED ROAD WORKS FOR COMPREHENSIVE RESIDENTIAL AND COMMERCIAL DEVELOPMENT ATOP SIU HO WAN DEPOT

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. ISM3232 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:-

- (i) construction of carriageway, temporary elevated footpath, permanent elevated footpath and cycle track, central reserve/refuge island at and near the slip road connecting North Lantau Highway to the proposed development;
- (ii) construction of footpath adjacent to the existing carriageway connecting Sham Shui Kok Drive;
- (iii) permanent closure and conversion of the proposed central reserves/refuge islands under PWP Item No. 7786CL Tung Chung New Town Extension (Tung Chung East and Road P1 (Tung Chung East to Tai Ho Section) Road Works) as described in G.N.3762 of 2018 and authorized as per G.N. 6886 of 2018 into carriageway;
- (iv) permanent closure and demolition of a section of the existing carriageway;
- (v) demolition and conversion of sections of the existing slope into carriageway;
- (vi) temporary closure and reconstruction of a section of the existing carriageway connecting Sham Shui Kok Drive; and
- (vii) ancillary works including associated road resurfacing, installation of traffic aids, electrical and mechanical, drainage, lighting, landscaping and utilities works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 24th day of August 2021.

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
