

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS J506—Design and Construction of Western Police Married Quarters (Programme No. 73JA)**.

The works include design and construction of Western Police Married Quarters at the site abutting Des Voeux Road West, Western Street and Queen's Road West comprising the demolition of the vacant Western Junior Police Officers Married Quarters block and the existing Inspectorate Quarters block, the construction of married quarters blocks offering a total of 540 units, the provision of parking spaces and ancillary facilities, the reprovisioning of the police station facilities and the provision of Police Public Relations Branch offices and relevant supporting facilities, together with associated building services installations, drainage and external works. The net operational floor area is approximately 32 819 square metres. The site area is approximately 3 700 square metres. The contract is scheduled to commence in October 2022 and for completion in August 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 25 February 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 25 February 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 25 February 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Confirmed Contractors on the List of Approved Contractors for Public Works in Group C for Buildings Category or joint ventures with participation of local and/overseas contractors with the lead participant or the major shareholder being on the above-mentioned approved list/category/group who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (1) the tenderer or in case of a joint venture tenderer, the lead participant/major shareholder in a joint venture tenderer, is a confirmed contractor on the List of Approved Contractors for Public Works in Group C for Buildings Category as at the original date set for the close of tender or, if this has been extended, the extended date; and
- (2) the tenderer must have completed at least one design and build building contract, in or outside Hong Kong with an adjusted original contract sum not less than HK\$700 million with building services installations (including plumbing and drainage) not less than HK\$140 million within the past 10 years counting from and including the original date set for the close of tender (i.e. 26 February 2012 and 25 February 2022). Only contract with substantial completion date falling within the above stated period will be considered.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by 4 January 2022 to Chief Quantity Surveyor/2 of Quantity Surveying Branch, Architectural Services Department, at 33rd Floor, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
