

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2022/02—Temporary Construction Waste Sorting Facilities (2022–2025)**. The works include the operation and maintenance of the existing temporary Construction Waste Sorting Facilities at Tseung Kwan O Area 137 and Tuen Mun Area 38. The works are scheduled to commence in May 2022 and will take about 36 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 25 February 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 25 February 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 25 February 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group B under Site Formation Category, or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group B under Site Formation Category who also meet the following qualifications and other conditions for participation stipulated below are invited to tender:—

- (i) the tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed in the past ten years counted from the original date set for the close of tender at least one site formation contract of adjusted contract sum not less than HK\$150 million in or outside Hong Kong. The adjusted contract sum shall be the original contract sum at the time of the contract award adjusted to current price as stipulated in the tender documents.

The detailed requirements on the tenderer's qualification are stipulated in the tender documents.

Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender with the highest overall score.

The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any tenderer about the terms of the offer.
