

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. YL/2021/03—Site Formation and Infrastructure Works for Yuen Long South First Phase Development—Contract 1**. The works mainly include:—

- (1) site clearance and formation (including land decontamination works) for about five hectares of land, together with the provision of associated engineering infrastructure;
- (2) construction of a single two-lane carriageway of about 130 metres long connecting to Lam Tai West Road;
- (3) construction of a single two-lane carriageway of about 130 metres long connecting to Long Hon Road;
- (4) construction of associated works including footpaths, slopes, retaining wall, landscaping works, water supply system, sewerage system and drainage system; and
- (5) implementation of environmental mitigation measures for the works mentioned above.

The works are scheduled to commence in September 2022 and will take about 32 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 17 June 2022. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 17 June 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 17 June 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group B under Site Formation Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 20 May 2022 to Chief Engineer/West 1, West Development Office, Civil Engineering and Development Department, on 9th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.
