

It is hereby notified that tenders are invited for the **Provision of Facility Management Services for the Public Cargo Working Areas, for a period of 36 months, tentatively from 1 February 2023 to 31 January 2026 (both dates inclusive) (Tender Reference: PASTR2022-12).**

A Tender submitted through Paper-based Tendering must be properly completed in triplicate and enclosed in a sealed envelope, clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Government Logistics Department, and must be deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon (Hong Kong Time) on 7 October 2022 (Friday). Late tenders or submission by fax, or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' as announced by the Government is/are in force at any time between 9.00 a.m. to 12.00 noon (Hong Kong Time) on 7 October 2022, the tender closing time will be postponed to 12.00 noon (Hong Kong Time) on the first working day (i.e. except Saturday, Sunday and public holiday) after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' as announced by the Government ceased to be in force. In case of blockage of the public access to the location of the specified tender box at any time between 9.00 a.m. to 12.00 noon (Hong Kong Time) on 7 October 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made *via* press releases on the website of Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.

This tender is not covered by the Agreement on Government Procurement of the World Trade Organization.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the tender with the highest overall score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
