

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS L505—Redevelopment of Hong Kong Correctional Services Academy Multi-purpose Gymnasium at 47 Tung Tau Wan Road, Stanley (Programme No. 71GI)**.

The works include redevelopment of the existing multi-purpose gymnasium of Hong Kong Correctional Services Academy into a new multi-purpose complex. The proposed scope of project comprises demolition of the existing multi-purpose gymnasium and construction of a new multi-purpose complex providing indoor sports hall, physical conditioning room, auditorium, indoor mini firing range, digital scenario training room and armoury with ancillary facilities, together with associated building services installations, drainage and external works. The construction floor area is approximately 6 115 square metres and the site area is approximately 2 100 square metres. The contract is scheduled to commence in April 2023 and for completion in June 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 4 November 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 4 November 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 4 November 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
