

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2275EM22T—Quadrennial Term Contract for Comprehensive Maintenance of Pumping Installations at Correctional Services Department and Other Disciplined Services Venues**. The scope of the Works includes comprehensive maintenance for pumping installations at various venues of the Correctional Services Department and other disciplined services. The Contract is scheduled to commence in January 2024 for expiry in January 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in Public Works Tender Box situated in Room 503, 5/F, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 4 August 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 4 August 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
