- (i) if Tropical Cyclone Warning Signal No. 8 or above is issued within two (2) hours before the Tender closing time and/or remains in force beyond the Tender closing time; or
- (ii) if a 'Black' Rainstorm Warning Signal is issued or 'Extreme Conditions after Super Typhoons' is announced by the Government (*via* the Information Services Department) within two (2) hours before the Tender closing time and/or remains in force beyond the Tender closing time; or
- (iii) when the Hong Kong Housing Authority announces the closure of the Housing Authority Headquarters (HAHQ) Building due to unforeseen circumstances occurring within two (2) hours before and beyond the closing time; or
- (iv) if Financial Services and Treasury Bureau issues a press release to notify members of the public that the closing time for all government procurement due on that day will be extended.
