

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. HY/2023/15, Structural Maintenance Works of Shenzhen Bay Bridge (Hong Kong Section), Contract 2**. The works mainly include the replacement of external pre-stressing tendons at south bound of Shenzhen Bay Bridge (Hong Kong Section). The works are scheduled to commence in December 2023 and will take about 65 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Office, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 3 November 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 3 November 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 3 November 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works in Class I—Supply and Installation of Prestressing Systems under Prestressed Concrete Works for Highway Structures Category, or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works in Class I—Supply and Installation of Prestressing Systems under Prestressed Concrete Works for Highway Structures Category, who also meet the following qualifications and conditions for participation are invited to tender:—

- (i) the tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least 1 construction contract involving supply and installation of prestressing systems under Prestressed Concrete Works for Highway Structures Category with the accumulated value of the supply and installation of prestressing systems of not less than HK\$300 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.
