**20230198      Term Contract (2024/2026) for Monitoring the Disposal of Inert Construction and Demolition Materials**

The scope of services includes monitoring the disposal of inert construction and demolition materials from the Hong Kong Housing Authority's construction sites to the Civil Engineering and Development Department's public fill reception facilities by developing, operating and maintaining database system to read, input, store, maintain and retrieve relevant data from dump trucks using radio-frequency identification technology.

Interested tenderers should send request for tender documents *via* email before 27 October 2023. Only tenderers who sent request in time would be allowed to collect the tender documents and submit the tender. (Send to email address: (chifung.wong@housingauthority.gov.hk) and copy to email address: (ty.chow@housingauthority.gov.hk)).

Upon receiving a reply email, tenderers should bring a copy of the reply email and collect tender documents from the General Registry (Contracts), Quantity Surveying Section (contact Telephone No.: 2761 6841), 8th Floor, Block 2, Housing Authority Headquarters, 33 Fat Kwong Street, Ho Man Tin, Kowloon from 10.00 a.m. on 3 November 2023.

A briefing session regarding the captioned tender would be organized for tenderers who collected tender documents. Maximum two members of the representative are allowed for each tenderer and they should bring a copy of the reply email to attend the briefing session. The time, date and location of the briefing session would be informed separately.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of two sealed envelopes with envelope number (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Hong Kong Housing Authority and placed in the Tender Box located at the Ground Floor, Block 2 of the Hong Kong Housing Authority Headquarters at 33 Fat Kwong Street, Kowloon, Hong Kong, before 10.00 a.m. on 15 December 2023.

Late tenders or tenders not deposited in the specified Tender Box will not be accepted.

The tender closing time will automatically be deferred to 10.00 a.m. on the first working day (excluding Saturday) in the following circumstances:—

- (a) if tropical cyclone warning signal No. 8 or above is hoisted and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (b) if a black rainstorm warning signal or 'extreme conditions after super typhoons' is announced by the Government and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (c) when the Director of Housing announces the closure of the Housing Authority Headquarters Building due to unforeseen circumstances and the Housing Authority Headquarters Building remains closed for any duration within two (2) hours before the tender closing time on the tender closing date.

For the avoidance of doubt, the tender closing time will remain unchanged if black rainstorm warning signal or tropical cyclone warning signal No. 8 or above, or 'extreme conditions after super typhoons' is lowered or cancelled or the Housing Authority Headquarters Building is reopened, two (2) hours or more before the tender closing time on the tender closing date.

The Hong Kong Housing Authority does not bind itself to accept the lowest tender or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
