# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF THE WU YUET BRIDGE ACROSS WU KING ROAD CONNECTING WU KING ESTATE AND WU KING ROAD GARDEN, AND A SECTION OF WU YUET STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 13 June 2024 (the 'Order'), authorized:-

- (I) the temporary closure of the Wu Yuet Bridge across Wu King Road connecting Wu King Estate and Wu King Road Garden, as delineated and shown in pink on the Plan numbered TMSE/G06/0010/1 during the period from 19 July to 18 October 2024; and
- (II) the temporary closure of the section of Wu Yuet Street between its junction with Wu King Road and a point about 135 metres northwest of the junction, as delineated and shown in blue on the Plan numbered TMSE/G06/0010/1, with details as follows:
  - (a) from 12:00 a.m. to 5:00 a.m. on 31 to 40 days during the period from 19 July 2024 to 18 July 2025, with all carriageway widths of the section of the road temporarily closed; and
  - (b) during the period from 19 July 2024 to 18 July 2025, except the period specified in (II)(a) above, with parts of the carriageway widths of the section of the road temporarily closed,

for the purposes of or incidental to the railway scheme of the Tuen Mun South Extension. A description of the works to be carried out, the footbridge and the section of the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the footbridge and the road affected by the Order on 5 July 2024.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of the footbridge and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge and the road affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of the footbridge and the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made

The footbridge and the road to be affected

Description of the works and the manner in which the footbridge and the road will be affected

The footbridge deck, staircase and ramp

- (a) Wu Yuet Bridge across Wu King Road connecting Wu King Estate and Wu King Road Garden, as delineated and shown in pink on the Plan numbered TMSE/G06/0010/1.
  - will be temporarily closed for demolition to facilitate the construction of the railway station and the associated railway facilities of the Tuen Mun South Extension.
- (b) The section of Wu Yuet Street between its junction with Wu King Road and a point about 135 metres northwest of the junction, as delineated and shown in blue on the Plan numbered TMSE/G06/0010/1.

From 12:00 a.m. to 5:00 a.m. on 31 to 40 days during the period from 19 July 2024 to 18 July 2025, all carriageway widths will be temporarily closed to facilitate the construction of the railway station and the associated railway facilities of the Tuen Mun South Extension.

During the period from 19 July 2024 to 18 July 2025, except the period specified above, parts of the carriageway widths will be temporarily closed to facilitate the construction of the railway station and the associated railway facilities of the Tuen Mun South Extension.
