

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF HANG WAN ROAD, AND
SECTIONS OF OLYMPIC AVENUE AND SUNG WONG TOI ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 5 November 2024 (the ‘Order’), authorized:-

- (I) the temporary partial closure of Hang Wan Road, as delineated and shown in blue on the Plans numbered SCL/G19/0072/1 and SCL/G22/0072/1;
- (II) the temporary partial closure of the section of Olympic Avenue between its junction with Sung Wong Toi Road and a point about 80 metres northeast of the junction, as delineated and shown in green on the Plans numbered SCL/G19/0072/1 and SCL/G22/0072/1; and
- (III) the temporary partial closure of the section of Sung Wong Toi Road between Olympic Avenue and a point about 85 metres southeast of its junction with Pak Tai Street, and the section of Sung Wong Toi Road between Ma Tau Chung Road and a point about 85 metres southeast of its junction with Pak Tai Street, as delineated and shown in brown on the Plans numbered SCL/G19/0072/1 and SCL/G22/0072/1,

during the period from 1 December 2024 to 31 March 2025 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0072/1 and SCL/G22/0072/1 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 15 November 2024.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Logistics Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
